ORGANIZATION OF WORK OF THE CONFERENCE INCLUDING THE ESTABLISHMENT OF COMMITTEES

Note by the Secretariat

Committee structure

- 1. Having regard to the Agenda for the Conference contained in 1P/CONF/1 and based on the fact that three teams of interpreters will be provided during the Conference, the following Committee structure is suggested:
 - Committee I
 - Committee II
 - Committee III
 - Committee IV
 - Drafting Committee
 - Credentials Committee
 - Steering Committee.

The suggested terms of reference of these Committees are as follows:

- (a) <u>Cormittee I</u> This Committee will consider the Articles of the Marine Pollution Convention and Agenda item 9 of the Conference relating to the minimization of accidental spillages.
- (b) <u>Committee II</u> This Committee will consider Annexes I, IV and V of the Marine Pollution Convention and the relevant Resolutions.

- (c) Committee III This Committee will consider Annexes II and III (and a possible new Annex concerning bulk solid substances) of the Marine Pollution Convention and the relevant Resolutions.
- (d) <u>Committee IV</u> This Committee will consider the draft Intervention Protocol.

The above four Committees will be open to all delegations and observers.

- (e) <u>Drafting Committee</u> This will be a Committee of restrictive membership appointed by the Plenary. It will examine the draft texts of the Convention (and its Annexes), Resolutions and other Instruments referred to it by the above Committees, and submit the texts to the Plenary. It will also prepare the draft Final Act of the Conference.
- (f) <u>Credentials Committee</u> This will be a small Committee appointed by the Plenary to examine the credentials of delegations.
- (g) Steering Committee This Committee will be composed of the President, Vice-Presidents and the Chairmen of Committees I, II, III and IV and the Drafting Committee. It may meet at the invitation of the President, whenever necessary. It will be responsible for reviewing the progress of work, co-ordinating the work of the various Committees, deciding on the day-to-day work and taking whatever measures may be necessary for the successful conclusion of the Conference.

Timetable for the Conference

2. The diagram shown in Annex I sets out a tentative timetable which will give an idea of how the Plenary and various Committees could work during the Conference. It should be noted in this connexion that although the Conference may no doubt wish to adhere as far as possible to the timetable agreed by it, it is possible that in the light of progress of work made by various Committees, readjustment of the timetable would become nocessary during the course of the Conference. Delegates for the Conference are, therefore, advised to bear this possibility in mind when making arrangements for attending the Conference.

3. On Monday, 8 October 1973 at 10.00 a.m. prior to the opening of the Conference, there will be a short meeting of the heads of delegations to discuss the Conference arrangements, particularly the election of officers.

Secretariat arrangements

4. Annex II shows the Executive Secretary and other Secretaries of the Plenary and Committees appointed by the Secretary-General in accordance with Rule 7(b) of the Provisional Rules of Procedure (MP/COMF/2).
