CONSIDERATION OF A DRAFT INTERNATIONAL CONVENTION FOR THE PREVENTION OF POLLUTION FROM SHIPS, 1973

Draft Text of Regulations of Annex IV, as agreed by the Drafting Committee

ANNEX IV

REGULATIONS FOR THE PREVENTION OF POLLUTION BY SEWAGE FROM SHIPS

Regulation 1

Definitions

For the purposes of the present Annex:

- (1) "New ship" means a ship:
 - (a) for which the building contract is placed, or in the absence of a building contract, the keel of which is laid, or which is at a similar stage of construction on or after the date of entry into force of the present Λnnex; or
 - (b) the delivery of which is three years or more after the date of entry into force of the present Annex.
- (2) "Existing ship" means a ship which is not a new ship.

- (3) "Sewage" means:
 - (a) drainage and other wastes from any form of toilets, urinals, and WC scuppers;
 - (b) drainage from medical premises (dispensary, sick bay, etc.) via wash basins, wash tubs and scuppers located in such premises;
 - (c) drainage from spaces containing living animals; or
 - (d) other waste waters when mixed with the drainages defined above.
- (4) "Holding tank" means a tank used for the collection and storage of sewage.
- (5) "From the nearest land" means from the baseline from which the territorial sea of the territory in question is established in accordance with the Geneva Convention on the Territorial Sea and the Contiguous Zone, done at Geneva 29 April 1958, except that, for the purposes of the present Convention "from the nearest land" off the north eastern coast of Australia shall mean from a line drawn from a point on the coast of Australia in

latitude 11° South, longitude 142°08! East to a point in latitude 10°35! South, longitude 141°55! East - thence to a point latitude 10°00! South, longitude 142°00! East, thence to a point latitude 9°10! South, longitude 143°52! East, thence to a point latitude 9°00! South, longitude 144°30! East, thence to a point latitude 13°00! South, longitude 144°00! East, thence to a point latitude 15°00! South, longitude 146°00! East, thence to a point latitude 18°00! South, longitude 147°00! East, thence to a point latitude 21°00! South, longitude 153°00, East, thence to a point latitude 21°00! South, longitude 153°00, East, thence to a point on the coast of Australia in latitude 24°42! South, longitude 153°15! East

Regulation 2

Application

The provisions of the present Annex shall apply to:

- (a) (i) new ships of more than 200 tons gross tonnage;
 - (ii) new ships of not more than 200 tons gross tonnage which are certified to carry more than 10 persons;
 - (iii) new ships which do not have a measured gross tonnage and are certified to carry more than 10 persons; and

- (b) (i) existing ships of more than 200 tons gross tonnage, 10 years after the date of entry into force of the present Annex;
 - (ii) existing ships of not more than 200 tons gross tonuage which are certified to carry more than 10 persons. 10 years after the date of entry into force of the present Annex; and
 - (iii) existing ships which do not have a neasured gross tonnage and are certified to carry more than 10 persons, 10 years after the date of entry into force of the present Annex.

Surveys

- (1) Every ship which is required to comply with the provisions of the present Annex and which is engaged in voyages to ports or offshore terminals under the jurisdiction of other Contracting States* shall be subject to the surveys specified below:
 - (a) an initial survey before the ship is put in service or before the certificate required under Regulation 4 of the present Annex is issued for the first time, which shall include a survey of the ship which shall be such as to ensure:
 - (i) when the ship is equipped with a sewage treatment plant the plant shall meet operational requirements based on standards and the test methods developed by the Organization:
 - (ii) when the ship is fitted with a system to comminute the sewage, such a system shall be of a type approved by the Administration:
 - (iii) when the ship is equipped with a holding tank the capacity of such tank shall be to the satisfaction of the Administration for the retention of all sewage having regard to the operation of the ship, the number of persons on board and other relevant factors. holding tank shall have a means to indicate visually the amount of its contents: and

Consequential changes will be necessary here and other parts of the limen in the light of the decision by Committee I that the term "Party(ies) to the Convention" should be used in place of "Contracting States".

(iv) that the ship is equipped with a pipeline leading to the exterior convenient for the discharge of sewage to a reception facility and that such a pipeline is fitted with a standard shore connection in compliance with Regulation 11 of the present Annex.

This survey shall be such as to ensure that the equipment, fittings, arrangements and material fully comply with the applicable requirements of the present Annex.

- (b) Periodical surveys at intervals specified by the Administration but not exceeding five years which shall be such as to ensure that the equipment, fittings, arrangements and material fully comply with the applicable requirements of the present Annex. However, where the duration of the International Sewage Pollution Prevention Certificate (1973) is extended as specified in Regulation 7(2) or (4) of present Annex, the interval of the periodical survey may be extended correspondingly.
- (2) The Administration shall establish appropriate measures for ships which are not subject to the provisions of paragraph (1) of this Regulation in order to ensure that the provisions of the present Annex are complied with.
- (3) Surveys of the ship as regards enforcement of the provisions of present Annox shall be carried out by officers of the Administration. The Administration may, however, entrust the surveys either to surveyors nominated for the purpose or to organizations recognized by it. In every case the Administration concerned fully guarantees the completeness and efficiency of the surveys.
- (4) After any survey of the ship under this Regulation has been completed, no significant change shall be made if the equipment, fittings, arrangements, or material covered by the survey without the approval of the Administration, except the direct replacement of such equipment or fittings.

Regulation 4

Issue of Certificate

- (1) in International Sewage Follution Prevention Certificate (1973) shall be issued, after survey in accordance with the provisions of Regulation 3 of this linex, to any ship which is engaged in voyages to ports or offshore terminals under the jurisdiction of other Contracting States.
- (2) Such Certificate shall be issued either by the Administration or by any persons or organization duly authorized by it. In every case the Administration assumes full responsibility for the certificate.

Issue of a Cortificate by Another Government

- (1) A Contracting Government may, at the request of the Administration, cause a ship to be surveyed and, if satisfied that the provisions of this Annex are complied with, shall issue or authorize the issue of an International Sewage Pollution Prevention Certificate (1973) to the ship in accordance with the present Annex.
- (2) A copy of the Certificate and a copy of the survey report shall be transmitted as early as possible to the Administration requesting the survey.
- (3) A Certificate so issued shall contain a statement to the effect that it has been issued at the request of the Administration and it shall have the same force and receive the same recognition as the certificate issued under Regulation 4 of the present Annex.
- (4) No International Sewage Pollution Prevention Certificate (1973) shall be issued to a ship which is entitled to fly the flag of a State, the Government of which is not a Contracting Government.

Regulation 6

Form of Cortificate

The International Sewage Pollution Prevention Certificate (1973) shall be drawn up in an official language of the issuing country in the form corresponding to the model given in Appendix to the present Annex. If the language used is neither English nor French, the text shall include a translation into one of these languages.

Regulation 7

Duration of Certificate

(1) An International Sewage Pollution Prevention Certificate (1973) shall be journal for a period specified by the Administration, which shall not exceed five years from the date of issue, except as provided in paragraphs (2), (3) and (4) of this Reculation.

- (2) If a ship at the time when the Certificate expires is not in a port or offshore terminal under the jurisdiction of the Centracting State whose flag the ship is entitled to fly, the Certificate may be extended by the Administration, but such extension shall be granted only for the purpose of allowing the ship to complete its veyage to the State whose flag the ship is entitled to fly or in which it is to be surveyed and then only in cases where it appears proper and reasonable to do so.
- (3) No Certificate shall be thus extended for a period longer than five months and a ship to which such extension is granted shall not on its arrival in the State whose flag it is entitled to fly or the port in which it is to be surveyed, be entitled by virtue of such extension to leave that port or State without having obtained a new Certificate.
- (4) A Cortificate which has not been extended under the provisions of paragraph (2) of this Regulation may be extended by the Administration for a period of grace of up to one month from the date of expiry stated on it.
- (5) A Certificate shall cease to be valid if significant alterations have taken place in the equipment, fittings, arrangement or material required without the approval of the Administration, except the direct replacement of such equipment or fittings.
- (6) A Cortificate issued to a ship shall cease to be valid upon transfer of such a ship to the flag of another State, except as provided in paragraph (7) of this Regulation.
- (7) Upon transfer of a ship to the flag of another State, the Government of which is a Contracting Government, the International Sewage Pollution Prevention Certificate (1973) shall remain in force for a period of not exceeding five months, provided that it is still valid at the end of that period or until the Administration issues another International Sewage Pollution Prevention Certificate (1973) to replace the former, whichever is earlier. The Contracting Government of the State whose flag the ship was entitled to fly hitherto shall transmit to the Administration as soon as possible after the transfer takes place a copy of the Certificate carried by the ship at the time of transfer, together with a copy of the relevant survey report, if available.

Discharge of Sewage

- (1) Subject to the provisions of Regulation 9 of the present Annex, the discharge of sewage into the sea is prohibited, except when:
 - (a) the ship is discharging comminuted sewage using a system approved by the Administration in accordance with Regulation 3(1)(a) at a distance of more than four nautical miles from the nearest land, or uncomminuted sewage at a distance of more than 12 nautical miles from the nearest land, provided that in any case, the sewage that has been stored in holding tanks shall not be discharged instantaneously but at a moderate rate when the ship is en route and proceeding at not less than 4 knots; the rate of discharge shall be approved by the Administration based upon standards developed by the Organization; or
 - (b) the ship has in operation an approved sewage treatment plant which has been certified by the Administration to meet the operational requirements referred to in Regulation 3(1)(a)(i) of the present Annex, and
 - (i) the test results of the plant are laid down in the ship's International Sewage Pollution Prevention Certificate (1973),
 - (ii) additionally, the effluent shall not produce visible floating solids in, nor cause discolouration of, the surrounding water;
 - (c) the ship is situated in the waters of a State and is discharging sewage in accordance with such less severe requirements as may be imposed by such State.
- (?) When the sewage is mixed with wastes or waste water having different discharge requirements, the more severe requirements shall apply.

Regulation 9

Exceptions

Regulation 8 of the present Annex shall not apply to:

- (a) the discharge of sewage from a ship necessary for the purpose of securing the safety of a ship and those on board or saving life at sea;
- (b) the discharge of sewage resulting from damage to a ship or its equipment if all reasonable precautions have been taken before and after the occurrence of the damage, for the purpose of preventing or minimizing the discharge.

Reception Facilities

- (1) Each Contracting Government undertakes to ensure the provision of facilities at ports and terminals for the reception of sewage, without causing undue delay to ships, adequate to meet the needs of the ships using them.
- (2) As regards paragraph (1) of this Regulation, each Contracting Government shall report to the Organization for transmission to the Contracting Governments concerned all cases where the facilities are alleged to be inadequate.

Regulation 11

Standard Discharge Connection

To enable pipes of reception facilities to be connected with the ship's discharge pipeline, both lines shall be fitted with a standard discharge connection in accordance with the following table:

Standard dimensions of flanges for discharge connections

Bolt circle diameter	170 min - /					
Slots in flance	4 holes 18 mm in diameter equidistantly placed on a bolt circle of the above diameter, slotted to the flange periphery. The slot width to be 18 mm					
Flange thickness	16 nm					
Bolts and nuts: quantity and diameter	4, each of 16 mm in diameter and of suitable length					

The flange is designed to accept pipes up to a maximum internal diameter of 100 mm and shall be of steel or other equivalent material having a flat face. This flange, together with a suitable gasket, shall be suitable for a service pressure of 6 kg/cm².

For ships having a moulded depth of 5 metres and less, the inner diameter of the discharge connection may be 38 millimetres.
