Addendum

38, Regulation 3

Insert the footnote to paragraph (a) as follows: "Reference is made to Recommendation on Test Method for Gualifying Marine Construction Materials as Non-Combustible. adopted by the Organization by Resolution A.270(VIII)."

- Insert the footnote to paragraphs (b) and (c) as follows: 39. "Reference is made to Recommendation for Fire Test Procedures for "A" and "B" Class Divisions, adopted by the Organization by Resolutions A.163(ES.IV) and A.215(VII)."
- 40. Regulations 27, 40 and 57

Insert the footnote to paragraph (e) of Regulation 27, to subparagraph (a)(iii) of Regulation 40 and to sub-paragraph (b)(v) of Regulation 57 as follows:

"Reference is made to Guidelines on the Evaluation of Fire Hazard Properties of Materials, adopted by the Organization by Resolution A.166(ES.IV)."

Regulations 27, 41, 51 and 57 41.

Insert the footnote to paragraph (h) of Regulation 27, to the heading of Regulation 41, to paragraph (c) of Regulation 51 and to sub-paragraph (a)(viii) of Regulation 57 as follows:

43. Parts A and D

Insert the footnote to headings of Part A and Part D as follows:

"Reference is made to Recommendation on Safety Measures
for Periodically Unattended Machinery Spaces of Cargo Ships
Additional to those normally Considered Necessary for an
Attended Machinery Space, adopted by the Organization by
Resolution A.211(VII)."

44. Regulation 56

Replace sub-paragraph (f)(i) by the following:

"(i) No doors shall be permitted in such boundaries, except that doors to those spaces not having access to accommodation and service spaces, such as cargo control stations, provision rooms, and store rooms may be permitted by the Administration. Where such doors are fitted, the boundaries of the space shall be insulated to "A-60" Class. Bolted plates for removal of machinery may be fitted in such boundaries."

45. Regulation 47

In sub-paragraph (f)(1) replace the words "a fixed fire extinguishing gas system" by "a fixed gas fire-extinguishing system."

46. Regulation 52

In sub-paragraph (f)(i) replace the words "a fixed fire extinguishing system" by "a fixed gas fire-extinguishing system."
