# IMCO

RESOLUTION A.304(VIII) adopted on 23 November 1973

INTERNATIONAL CONFERENCE ON SAFETY OF LIFE AT SEA, 1974

THE ASSEMBLY,

BEING AWARE of the purposes of the Organization concerning maritime safety and efficiency of navigation as stated in Article 1 of the IMCO Convention,

NOTING the significant contributions made by the International Convention for the Safety of Life at Sea, 1960, towards the achievement of this objective,

RECOGNIZING the need to keep the technical provisions of the said Convention up to date in the light of technological progress,

NOTING with concern that none of the numerous amendments to the Convention adopted hitherto by the Assembly has yet received sufficient acceptances by Contracting Governments so as to bring them into force,

CONCURRING with the view of the Maritime Safety Connittee that the effective implementation of these amendments could best be achieved by concluding a new Safety Convention superseding the existing 1960 Safety Convention and embodying such amendments,

CONCURRING **FL**SO with the view of the Maritime Safety Connittee that the new Safety Convention should also embody provisions for rapid entry into force of the Convention and for improved and accelerated amendment procedures so that any future amendments may be brought into force expeditiously,

NOTING Article 3(b) of the IMCO Convention concerning the convening of conferences,

TAKING NOTE of the progress made by the Maritime Safety Connittee in the preparatory work for the Conference,

DECIDES to convene in October 1974, an International Conference to conclude a new convention which would supersede as between the Parties to this Convention, the International Convention for the Safety of Life at Sea, 1960,

DECIDES FURTHER that the principal objective of the Conference shall be to replace the existing 1960 Safety Convention by a new Convention, substantially in conformity with the technical provisions of the 1960 Convention, which shall incorporate:

- (a) provisions for rapid entry into force of the Convention;
- (b) improved and accelerated amendment procedures;
- (c) amendments to the 1960 Convention which have already been adopted by the Assembly; and
- (d) new Regulations which are recommended by the Assembly for inclusion in the new Convention;

REQUESTS the Secretary-General to make the nocessary arrangements for the Conference, including the issue of invitations to States, Members of the United Nations and its Specialized Agencies and the International Atomic Emergy Agency and Parties to the Statute of the International Court of Justice, together with observers from such inter-governmental and non-governmental organizations as are usually present at conferences convened by IMCO. RESOLUTION A.315(ES.V) adopted on 17 October 1974

AMENDMENTS TO THE IMCO CONVENTION

The Assembly,

RECALLING Resolution A.69(ES.II) by which it adopted anendments to the IMCO Convention increasing the nonbership of the Council and Resolution A.70(IV) by which amendments were adopted to the IMCO Convention to increase the number of members in the Maritime Safety Committee and to modify the method of their election,

NCTING AND WELCOMING the increase in the nenbership of the Organization since these anendments were adopted,

RECOGNIZING the need to ensure at all times that the principal organs of the Organization are representative of the total membership of the Organization and ensure equitable geographic representation of Member States on the Council,

RECALLING its Resolution A.314(VIII) by which it decided to convene an Ad Hoc Working Group to study proposed amendments to the IMCO Convention concerning the size and composition of the Council and the Maritime Safety Committee and any consequential related amendments,

HAVING CONSIDERED the Report of the Ad Hoc Working Group, including the Working Group's recommendations on proposed amendments to the IMCO Convention,

HAVING ADOPTED at the fifth extraordinary session of the Assembly held in London from 16 to 18 October 1974, amendments, the texts of which are contained in the Annex to this Recolution, to Articles 10, 16, 17, 18, 20, 28, 31 and 32 of the Convention on the Inter-Governmental Maritime Consultative Organization,

HAVING DETERMINED, in accordance with the provisions of Article 52 of the Convention, that these amendments are of such a nature that any Member which hereafter declares that it does not accept the amendments and which does not accept the amendments within a period of twelve months after the amendments come into force shall, upon the expiration of this period, cease to be a Party to the Convention.

REQUESTS the Secretary-General of the Organization to deposit the adopted anendments with the Secretary-General of the United Nations in accordance with Article 53 of the IMCO Convention and to receive declarations and instruments of acceptance as provided for in Article 54,

INVITES the Member Governments to accept each anendment at the earliest possible date after receiving a copy thereof from the Secretary-General of the United Nations by communicating the appropriate instrument of acceptance to the Secretary-General.

## AMENDMENTS TO THE CONVENTION ON THE INTER-GOVERNMENTAL MARITIME CONSULTATIVE ORGANIZATION

#### Article 10

#### The existing text is replaced by the following:

An Associate Member shall have the rights and obligations of a Member under the Convention except that it shall not have the right to vote or be eligible for membership on the Council and subject to this the word "Member" in the Convention shall be deemed to include Associate Member unless the context otherwise requires.

## Article 16

## The existing text of paragraph (d) is replaced by the following:

(d) To elect the Members to be represented on the Council as provided in Article 17.

### Article 17

## The existing text is replaced by the following:

The Council shall be composed of twenty-four Members elected by the Assembly.

## Article 18

### The existing text is replaced by the following:

In electing the Members of the Council, the Assembly shall observe the following criteria:

- (a) Six shall be States with the largest interest in providing international shipping services;
- (b) Six shall be other States with the largest interest in international seaborne trade;

(c) Twelve shall be States not elected under (a) or (b) above, which have special interests in maritime transport or mavigation, and whose election to the Council will ensure the representation of all major geographic areas of the world.

### Article 20

### The existing text is replaced by the following:

- (a) The Council shall elect its Chairman and adopt its own Rules of Procedure except as otherwise provided in the Convention.
- (b) Sixteen Members of the Council shall constitute a quorum.
- (c) The Council shall neet upon one nonth's notice as often as may be necessary for the efficient discharge of its duties upon the surmons of its Chairman or upon request by not less than four of its Members. It shall neet at such places as may be convenient.

## Article 28

## The existing text is replaced by the following:

The Maritime Safety Committee shall consist of all the Members.

### Article 31

#### The existing text is replaced by the following:

The Maritime Safety Committee shall meet at least once a year. It shall elect its officers once a year and shall adopt its own Rules of Procedure.

## .rticle 32

#### This Article is deleted.

Articles 33 through 63 are renumbered accordingly.

RESOLUTION A.316(ES.V) adopted on 18 October 1974 WIDER REPRESENTATION JN THE COUNCIL

THE ASSEMBLY,

RECALLING Resolution A.315(ES.V) adopted unanimously by the fifth extraordinary session of the Assembly of the Organization regarding the increase of the membership and composition of the Council and the opening of the Maritime Safety Committee to all Members,

NOTING FURTHER that a high number of the members of the Organization is constituted by developing countries and that such fact has not so far been reflected in the composition of the governing bodies of the Organization,

DECLARES that the amendments included in the above-mentioned Resolution were adopted as a recognition of the need of a wider and more equitable representation in the Council of all sectors interested in the work of the Organization, having regard to the increased membership of the Organization and the need to improve the representation of developing countries on the Council.
