Re-arrangement of Existing Fire Safety Regulations
In Proposed Chapter II bis

Note by the Secretariat

It will be recalled that the proposed Chapter II bis Fire Protection, Fire Detection and Fire Extinction (SOLAS/CONF/4/1) is a re-arrangement of existing fire safety regulations with some unavoidable editorial modifications thereto but without substantive change (SOLAS/CONF/INF.2 paragraph 22).

In order to assist in assessing the re-arrangement of the material in Chapter II bis, the Secretariat has prepared the attached list. In the left-hand column of this list the new Regulation numbers of Chapter II bis are quoted. In the right-hand column reference is made to corresponding Regulation numbers in the present Chapter II, as amended and/or the Regulations concerning Fire Safety Measures for Tankers and Combination Carriers which were adopted by the eighth Assembly for inclusion in the draft of the 1974 SOLAS Convention (Res. A.271(VIII)).
