## RESEARCH WORK UNDERTAKEN BY THE IMO INTERNATIONAL MARITIME LAW INSTITUTE

THE ASSEMBLY,

RECALLING articles 2(e) and 15(k) of the Convention on the International Maritime Organization concerning the functions of the Organization and the Assembly in relation to the facilitation and promotion of technical co-operation,

RECALLING ALSO that the IMO International Maritime Law Institute (IMLI) was established to serve the global maritime community as the Organization's apex institution for tertiary-level maritime law education, in furtherance of IMO's purposes and objectives,

RECALLING IN PARTICULAR resolutions A.900(21), on *Objectives of the Organization in the 2000s*, and A.934(22), on *Sustainable financial support for the IMO International Maritime Law Institute*, through which the Assembly, respectively, acknowledged the special contribution of IMLI to the attainment of the objectives of the Organization, and reaffirmed the importance and continued necessity of the Institute, as a high-level legal training institution for providing, *inter alia*, technical advice in furtherance of the objectives and goals of the Organization and its Member States,

RECALLING FURTHER that, as a centre of academic excellence in the maritime legal field, IMLI undertakes original and applied research into aspects of international maritime law, with a view to promoting the achievement of the highest practicable global standards in this field and providing a mechanism for the international exchange, transfer and application of related knowledge,

RECOGNIZING that research is an important component of IMLI's academic activities, which strengthens and enhances its programmes of study and contributes positively to the fulfilment of its educational mandate.

RECOGNIZING ALSO that IMLI remains committed to research of the highest standard, which not only promotes knowledge creation, stimulates teaching and enriches higher learning, but also enhances its international academic reputation and can provide a valuable source of income towards the provision of fellowships for students and corporate development purposes,

  - (a) make use of the competencies of IMLI in commissioning legal research related to their respective fields of activity; and
  - (b) take into account, in the performance of their activities, the findings and recommendations of the research work undertaken by IMLI.
