## Resolution A.1109(29)

## RELATIONS WITH NON-GOVERNMENTAL ORGANIZATIONS

THE ASSEMBLY,

RECALLING Part XVI of the Convention on the International Maritime Organization and, in particular, Article 67,

BEARING IN MIND the Rules and Guidelines for Consultative Status of Non-Governmental International Organizations with the International Maritime Organization ("the Rules and Guidelines"),

RECALLING that rule 1 of the Rules and Guidelines requires that consultative status granted by the Council to such organizations be subject to approval by the Assembly,

RECALLING ALSO that rule 10 of the same Rules and Guidelines provides for a periodic review by the Council of the list of non-governmental international organizations in consultative status with IMO and for a report to be submitted to the Assembly on the continuation, or otherwise, of such status,

BEARING IN MIND the change of initials, from OGP to IOGP, denoting the International Association of Oil & Gas Producers,

BEARING ALSO IN MIND the amalgamation between the International Chamber of Shipping (ICS) and the International Shipping Federation (ISF), as well as the decision to operate at IMO under the banner of ICS,

NOTING the subsequent decision of the Council, at its 113th session, to withdraw ISF's consultative status with IMO,

NOTING ALSO the decision of the Council, at its 113th and 114th sessions, to grant consultative status to the International Water Mist Association (IWMA) and the International Port Community Systems Association (IPCSA), respectively,

NOTING FURTHER the decision of the Council, at its 114th session, to withdraw the consultative status granted to PIANC, the World Association for Waterborne Transport Infrastructure (PIANC),



RECALLING the decision of the Council, at its 114th session, to encourage the participation of the International Ocean Institute (IOI) and the Iberoamerican Institute of Maritime Law (IIDM) in those IMO meetings which are relevant to their work,

REAFFIRMING that all non-governmental international organizations in consultative status are required to contribute substantially to the work of IMO in their respective fields of work,

- 1 APPROVES the decision of the Council to grant consultative status to IWMA and IPCSA;
- 2 APPROVES ALSO the decision of the Council to withdraw the consultative status granted to ISF and PIANC;
- 3 ENDORSES the decision of the Council regarding the maintenance of consultative status by the remaining organizations; and
- 4 APPROVES FURTHER the following list of non-governmental international organizations in consultative status with IMO:
