RESOLUTION A.1194(33)

**Adopted on 6 December 2023
(Agenda item 19(c))**

RELATIONS WITH NON-GOVERNMENTAL ORGANIZATIONS

THE ASSEMBLY,

RECALLING Part XVI of the Convention on the International Maritime Organization and, in particular, Article 67,

BEARING IN MIND the Rules and Guidelines for Consultative Status of Non-Governmental International Organizations with the International Maritime Organization ("the Rules and Guidelines"),

RECALLING that rule 1 of the Rules and Guidelines requires that consultative status granted by the Council to such organizations be subject to approval by the Assembly,

RECALLING ALSO that rule 12 of the same Rules and Guidelines provides for a periodic review by the Council of the list of non-governmental international organizations in consultative status with IMO and for a report to be submitted to the Assembly on the continuation, or otherwise, of such status,

BEARING IN MIND that the European Association of Internal Combustion Engine Manufacturers (EUROMOT) has changed its name to "European Association of Internal Combustion Engine and Alternative Powertrain Manufacturers (EUROMOT)",

NOTING the decisions of the Council, at its 128th and 129th sessions, to grant consultative status to the TIC Council, the Environmental Defense Fund (EDF) and the International Pollutants Elimination Network (IPEN), and to grant consultative status, on a provisional basis, for no more than two years, after which a review should be conducted, to the Zero Emissions Ship Technology Association (ZESTAs) and the International Federation of Freight Forwarders Associations (FIATA), as well as to extend the Inuit Circumpolar Council (ICC)'s consultative status for an additional period of two years, after which a review should be conducted,

NOTING ALSO the decision of the Council, at its 129th session, to give the International Spill Control Organization (ISCO) a final reminder of its obligations and to withdraw the International Ocean Institute (IOI)'s consultative status,

REAFFIRMING that all non-governmental organizations in consultative status are required to contribute substantially to the work of IMO in their respective fields of work,

1 APPROVES

- .1 the decision of the Council to grant consultative status to the TIC Council, the Environmental Defense Fund (EDF) and the International Pollutants Elimination Network (IPEN);
- .2 the decision of the Council to grant consultative status, on a provisional basis, for no more than two years, after which a review should be conducted, to the Zero Emissions Ship Technology Association (ZESTAs) and the International Federation of Freight Forwarders Associations (FIATA), as well as to extend the Inuit Circumpolar Council (ICC)'s consultative status for an additional period of two years, after which a review should be conducted;
- .3 the decision of the Council to withdraw the consultative status from the International Ocean Institute (IOI);
- .4 the decision of the Council to maintain the consultative status of the remaining organizations; and
- .5 the following list of non-governmental international organizations in consultative status with IMO:
