THE ASSEMBLY,

NOTING Article 49 of the Convention of the Inter-Governmental Maritime Consultative Organization concerning acceptance by the Organization of such functions, resources and obligations as may be transferred to the Organization from a Government or from another international organization by international agreement,

RECALLING Resolution A.242(VII) concerning the preparations for the United Nations Conference on the Human Evironment (Stockholm, 5 to 6 June 1973), by which the Assembly requested the Council, the Maritime Safety Committee and the Secretary-General to implement any decisions of that Conference entrusting responsibilities to IMCO including functions in respect of the control of the dumping of shore-generated waste by ships or other craft operating in the marine environment,

RECALLING FURTHER Resolution A.369(IX) by which the Assembly made provision in the work programme and budget for 1976/77, inter alia, for the staff and other resources required to enable IMCO to undertake responsibilities in respect of the Convention on the Prevention of Marine Pollution by Dumping of Wastes and Other Matter, adopted by the Inter-Governmental Conference convened by the Government of the United Kingdom in November 1972,

BEING INFORMED that the said Convention entered into force on 30 August 1975,
