RECALLING that it adopted by resolution A.413(XI) the Guidelines on Mandatory Annual Surveys, Unscheduled Inspections of All Cargo Ships as well as Intermediate Surveys on Tankers of Ten Years of Age and Over, under the Protocol of 1978 relating to the International Convention for the Safety of Life at Sea, 1974,

HAVING CONSIDERED the amendments to the Guidelines approved by the Maritime Safety Committee at its forty-fourth session,

- ADOPTS the amendments to the Guidelines annexed to resolution A.314(XI), as set out in Annex to the present resolution;
- 2 INVITES all Governments concerned to follow the Guidelines as amended in conducting surveys and inspections required under the provisions of the Protocol of 1978 relating to the International Convention for the Safety of Life at Sea, 1974.
