Subject: "Making headway on the IMO MASS Code" Symposium co-sponsored by IMO and the Republic of Korea (30 May 2023)

1 The Secretary-General has the honour to invite participation in the forthcoming IMO/Republic of Korea Symposium on "Making headway on the IMO MASS Code", scheduled to take place in hybrid mode on **Tuesday**, **30 May 2023** (prior to MSC 107), at IMO Headquarters, 4 Albert Embankment, London SE1 7SR.

2 The Symposium is co-hosted by IMO and the Government of the Republic of Korea to share their efforts in contributing to the development of the IMO MASS Code.

3 Expected to be adopted as a mandatory Code under SOLAS in the future, the goal-based MASS Code will need to establish a robust safety regime for MASS that ensures safety of life at sea, as well as safety of cargo on board and the MASS itself. In order to contribute to the development of the MASS Code and to establish a network for international cooperation, the Symposium will be divided into three sessions. It will be held with a focus on sharing insights on autonomous operation technology which is being developed in the Republic of Korea and other States, as well as seeking ways to link autonomous ships and ports, to assist in the development of the new MASS Code.

4 The Symposium will be conducted in English only without interpretation and will also be streamed on the IMO YouTube channel. Further details regarding the Symposium, including the agenda, will be issued in due course.

5 Registration is mandatory for active participation and further details are set out in the annex. On-site participants are responsible for their own travel and accommodation. Visa support letters can be provided upon request once registration has been completed.

## ANNEX

## REGISTRATION

Member Governments, UN Agencies, IGOs and NGOs are required to provide, prior to the meeting date, the names of all the members of their delegations attending the meeting via the Online Meeting Registration System (OMRS), as advised in Circular Letter No.4336 of 5 November 2020. This facilitates both their entry into the building and the production of the list of participants by the Secretariat.

Active participants are those attending meetings at IMO Headquarters in-person (attending meetings in the Main Hall or committee rooms 9 or 10) or remote-active participants authorized to take the floor, and passive participants are those able to follow proceedings remotely via live streaming.

Remote-active participants will receive an email with a joining link for Zoom. The Zoom link is unique and should only be used by the receiver. The link should not be shared with any other person. In-person participants should not join the Zoom meeting while physically present in the Main Hall or committee rooms, as this will impact the hybrid system, and reduce the number of licenses available for those joining remotely.

Remote-passive participants will be sent a link to a Web stream of the session (live streaming), which will be broadcast via the IMODOCS page.

Delegates wishing to change their participation status from in-person to remote-active must change their status through their respective OMRS Delegation Coordinator in the OMRS. Subsequently, they will receive a joining link to the meeting.

For those delegates attending the meeting in-person and who have completed the registration procedure, an electronic access card will be issued at IMO to pass through the security barrier in the IMO building. Issuing the access card will require photographic proof of identity, e.g. passport, identity card or driving licence. Delegates may also be required to show proof of identity at any time while they are in the Headquarters building if requested by IMO Security. In view of the significant costs incurred in producing access cards, delegates who have previously been issued with one are kindly requested to bring it with them for reactivation.
