- 2.1 The Committee will recall that MEPC 83 requested the Secretariat to carry out an editorial review and prepare a consolidated version of the draft amendments to MARPOL Annex VI, containing those draft amendments approved at both MEPC 82 and MEPC 83, in the form of a draft revised MARPOL Annex VI (MEPC 83/17, paragraph 7.45 and annex 11).
- 2.2 In this context, the Committee will be invited to consider, with a view to adoption, in accordance with MARPOL article 16(2), the draft revised MARPOL Annex VI 2025 (MEPC 83/17, annex 11 and MEPC/ES.2/2, annex).
- 2.3 The aforementioned consolidated amendments were circulated by the Secretary-General, in accordance with MARPOL article 16(2)(a), by means of Circular Letter No.5005.
- 2.4 A drafting group is expected to be established to prepare the final text of the amendments.
