CIRCULAR

SUBJECT: "INFORMATION PROVIDED BY THE HELLENIC REPUBLIC REGARDING AMENDMENTS OF LEGISLATION CONCERNING THE ACQUISITION AND POSSESSION OF WEAPONS ON BOARD SHIPS"

- 1. The Hellenic Maritime Administration wishes to inform the shipping community of the following amendments of the relevant national legislative framework as regards the acquisition and possession of weapons on board ships which has been put into effect on March 20th 2020.
- 2. In particular according to the provisions of Law 4678/2020¹ the categories of weapons/ firearms for which a transit permit is required are expanded in order to include all types of weapons/firearms and other objects as defined in the attached annex.
- 3. Additionally, the scope of certain cases where a transit declaration was required, is now expanded to include apart from ships of any flag carrying these items that call at a Greek port or anchorage without being unloaded or uploaded and brought in the Greek territory, also ships of any flag sailing in the Greek territorial waters even without calling a Greek port or anchorage. In the latter case, when a ship enters a sea area under the jurisdiction of the Hellenic Republic, the declaration of transit must be submitted by the master by any means available (fax/e-mail) to the local Hellenic Coast Guard Authority. The declaration of transit must include the required information specified in the attached transit declaration form, in Greek and/or English. E-mail addresses of the local Hellenic Coast Guard's

Authorities are attached thereto. Finally, their contact information is also available online at the HCG's web site (http://www.hcg.gr/limArxes).

4. Furthermore, in cases of ships carrying dangerous goods/cargoes² which may cause serious dangers to public order and security of the country, the masters are required to inform additionally the Directorate of Security and Sea Borders Protection by submitting a written notification³, at least twelve (12) hours before entering the sea areas under the jurisdiction of the Hellenic Republic. The notification shall include the same information as the declaration of transit. The Hellenic Coast Guard reserves the right to direct the master to follow a specific route or to object to the passage of the ship if this passage is not considered as "innocent passage", according to UNCLOS 1982.

5. Finally, the new legislation prohibits passengers travelling onboard cruise ships or on ships performing international voyages under foreign flag, to carry out recreational target shooting while the ship transits sea areas under the jurisdiction of the Hellenic Republic.

6. Penal, civil, administrative and disciplinary penalties, where appropriate, are imposed for failure to comply with the relevant legislation⁴.
