- p Operational measures shall ensure that the risk of developing toxic and/or explosive gases is minimized during loading, transport, unloading and cleaning, including measures to prevent sedimentation of the cargo in the tanks, such as continuous circulation, and measures to be taken if unforeseen release of gas occurs. Carriage requirements in columns g, j and k have been assigned due to the cargo's tendency for anaerobic bacterial activity and the risk of developing and release of toxic and explosive gases. In column o, in addition to special requirement 15.15, lower explosive limit (LEL) detection equipment shall be provided on board ships carrying this cargo that is prone to the formation of toxic and/or explosive gas caused by bacterial activity.
