Background

1 The last two sessions of the Committee, FAL 45 and FAL 46, were held virtually. Due to the limitations of virtual meetings, the Committee on neither occasion managed to consider the complete agenda for the respective sessions. Taking into account the high number of agenda items and the limited time of remote meetings, the Chair intends to consider some of the agenda items by correspondence.

Proposed way forward

2 With a view to alleviating the burden of the virtual meetings and to progressing the work as much as possible, taking into account the precedents set by the Council, MSC and MEPC, the following agenda items <u>should be</u> considered by correspondence prior to FAL 46:

- .1 agenda item 11 Unsafe mixed migration by sea;
- .2 agenda item 12 Consideration and analysis of reports and information on persons rescued at sea and stowaways;



- .3 agenda item 18 Technical cooperation activities related to facilitation of maritime traffic;
- .4 agenda item 19 Relations with other organizations; and
- .5 agenda item 20 Application of the Committee's procedures on organization and method of work.

3 The annex to this document sets out a list of documents submitted under the above agenda items to the FAL Committee, together with some background information, as appropriate, and the Chair's proposals on what relevant action should be taken, to be considered by correspondence prior to FAL 46.

4 Member States and international organizations are invited to provide their comments, if any, on the Chair's proposed actions to be taken by the Committee in relation to the documents to be considered by correspondence prior to the virtual meeting, to info@imo.org by 4 March 2022 (to allow for the preparation of a document replying to any comments by the deadline for commenting documents for FAL 46, i.e. 18 March 2022). In the event that substantial comments on a particular proposal are received, the Chair, in consultation with the Member State(s) concerned and the Secretariat, will aim to modify the proposal in question, or alternatively suggest to defer the consideration of the matter to FAL 47.

5 The Secretariat, in consultation with the Chair, will collate all comments received in a single document, which will also contain explanations on how these comments were addressed. This document will be circulated in good time before FAL 46.

6 The Chair's proposals, as may be amended following receipt of comments, will be subject to endorsement by the Committee during the virtual meeting.

Action requested of the Committee

7 The Committee is invited to:

- .1 endorse the Chair's proposals on the arrangements for the consideration of selected agenda items by correspondence, as set out in this document; and
- .2 consider the Chair's proposals for the actions to be taken in relation to the documents considered by correspondence prior to the virtual meeting, noting that those proposals, as may be amended following receipt of comments, will be subject to final endorsement during the virtual meeting.

1 AGENDA ITEM 11 – UNSAFE MIXED MIGRATION BY SEA

Documents to be considered through correspondence prior to the virtual meeting

No documents submitted to FAL 44 and FAL 45.

Background

In 2021, UNHCR launched an initiative to re-constitute the Inter-Agency Group on Safety of Life at Sea, to discuss, plan and execute coordinated joint action and advocacy to support the prevention of dangerous journeys at sea, SAR activities, and safe disembarkation. EOSG, ICS, ILO, IMO, IOM, OHCHR, OLA and UNODC have been invited to participate in the Group.

FAL 45 agreed to postpone the consideration of the agenda item on "Unsafe mixed migration by sea" and extended its target completion year to 2022.

MSC 104 considered the proposal of Denmark of an MSC resolution to reiterate the importance of effective and timely involvement of Governments in cases of rescue of migrants at sea by merchant ships. The Committee, taking into account the various views and suggestions, agreed to postpone further consideration of the matter to MSC 105 and invited Member States to submit comments to that session, with a view to finalizing the resolution then.

The Chair proposes that the Committee:

- .1 notes UNHCR's initiative to re-constitute the Inter-Agency Group on Safety of Life at Sea;
- .2 notes the discussions in MSC regarding the adoption of a new resolution to reiterate the importance of effective and timely involvement of Governments in cases of rescue of migrants at sea by merchant ships; and
- .3 agree to extend the target completion year of output 5.13 "IMO's contribution to addressing unsafe mixed migration by sea" to 2023, with the aim of keeping the Committee informed of developments.

2 AGENDA ITEM 12 – CONSIDERATION AND ANALYSIS OF REPORTS AND INFORMATION ON PERSONS RESCUED AT SEA AND STOWAWAYS

Documents to be considered through correspondence prior to the virtual meeting

Background

Consideration and analysis of reports and information on stowaways

The information of the stowaway incidents which have been reported to the Organization since FAL 43, the last session which the Committee considered this agenda item, is as follows:

The number of reports received by the Organization since FAL 43 is 159, which involved 289 stowaways; and the total number of reports until 31 December 2021 has been 4,783, which involved 14,741 stowaways.

FAL 43 considered document FAL 43/13 (P&I Clubs), which provided information on an analysis of claims data collated by them on stowaway cases in the policy years 2007, 2011, 2014 and 2017. FAL 43 noted that that the figures provided by the P&I Clubs suggested that the scale of the stowaway problem was still significant. While the number of incidents had nearly halved during the 11-year period from 2007 to 2017, the number of stowaways per incident had increased by nearly 50%, and the total cost net of deductible to the P&I Clubs, including fines imposed by Governments on shipowners, had decreased by some 30%, from \$14.3 million in 2007 to \$9.5 million in 2017. The P&I Clubs noted a significant reduction in the number of incidents emanating from some West African ports, which could represent a positive outcome of the seminars on stowaways organized by IMO in Abidjan and Durban in 2014 and in Yaoundé in 2017.

FAL 43, having noted that the statistics published by IMO presented lower figures of stowaways than the figures reported by the P&I Clubs, urged Member States and international organizations to provide timely and accurate information on stowaway cases to the Organization in accordance with standard 4.7.1 of the FAL Convention, making use of the relevant GISIS module.

Consideration and analysis of reports and information on persons rescued at sea

Since the launch of the Inter-agency platform for information-sharing on migrant smuggling by sea in GISIS¹ (on 6 July 2015), only 23 incidents had been entered in the database, by two Member States.

The Chair proposes that the Committee:

- .1 notes the information on the number of reports of incidents and the stowaways involved;
- .2 urges Member States and international organizations to provide timely and accurate information on stowaway cases to the Organization in accordance with standard 4.7.1 of the FAL Convention, making use of the relevant GISIS module;
- .3 invites the P&I Clubs to present information on stowaway cases, as this is an effective information source to understand the complexity of stowaway incidents;
- .4 notes the number of reports on persons rescued at sea entered in GISIS since 2015; and

.5 notes the low level of reporting of migrant incidents at sea and of suspected smugglers and vessels, as requested by the Interim measures for combating unsafe practices associated with the trafficking, smuggling or transport of migrants by sea (MSC.1/Circ.896/Rev.2), and encourages Member States to provide and update the information in the Inter-agency platform for information-sharing on migrant smuggling by sea in GISIS.
