General

- 1 The Global Integrated Shipping Information System (GISIS) presently consists of 34 modules, with a further six under development, for the collection, processing and sharing of shipping-related data in order to assist Member States and the Secretariat in carrying out their respective and complementary duties, generate reports and provide information about shipping to the public.
- There are approximately 260,000 public-registered IMO web accounts with access to the public area of GISIS. In addition, approximately 15,000 Member-authorized accounts have access to the Members' Area of GISIS.
