New countries join GreenVoyage2050

Several more countries have joined GreenVoyage2050. Some will receive support to develop National Action Plans (NAPs) for reducing shipping GHG emissions, while others will work on feasibility studies for zero or near-zero emission solutions for ships and ports. Third annual GHG-SMART training and site visit in Busan

The GHG-SMART Project held its third annual training and site visit in Busan, Republic of Korea (4-8 November), with maritime professionals from 13 SIDS and LDCs across Africa, Asia, the Caribbean, and the Pacific. Topics covered decarbonization, alternative fuels, National Action Plans (NAPs), port and ship efficiency, and climate finance.

These initiatives aim to demonstrate quantifiable GHG reductions and offer scalable solutions, utilizing bioenergy, wind power and "Justin-Time" port call optimization.

New Tools and Insights: WMU's literature review and FFT portal updates

The World Maritime University (WMU) is conducting a literature review to assess the potential impacts of IMO mid-term measures on food security. Outcomes will be presented at the GHG Expert Workshop (GHG-EW 6) on 13 February 2025. Additionally, the FFT online portal now includes the Fuel Cost Calculator and Carbon Intensity Toolkit, developed by the Mærsk Mc-Kinney Møller Center for Zero Carbon Shipping and the Energy and Environmental Research Associates (EERA).

IMO heads to COP 29 to promote net-zero framework for shipping

IMO Secretary-General Arsenio Dominguez led a delegation to the annual UN Climate Change Conference COP 29 held in Baku, Azerbaijan (11-22 November). IMO submitted a document to SBSTA 61, outlining the progress made and actions taken to date to support maritime climate action. An official side event at COP 29 brought together IMO, the International Civil Aviation Organization (ICAO) and the United Nations Economic Commission for Europe (UNECE) to discuss the theme: "Decarbonising Transport: Policies and Strategies For Aviation, Maritime and Land".

The event also explored fuel efficiency, strategies for marine protected areas, and promoted gender equality.




IMO-WMU workshop on underwater radiated noise reduction policies and strategies

OceanLitter programme highlights IMO action on marine litter at INC-5

The OceanLitter Programme was unveiled at INC-5 in Busan, Korea (25 November-2 December) with a dedicated promotional booth to share information about the programme's activities and future with a global audience. The event brought together about 2,000 participants from over 170 countries. The booth helped connect with stakeholders interested in addressing sea-based marine plastic litter.

Jamaica national event on port waste management plan and port State control

National workshops on port waste management plan were held in Maceio, Brazil (2-3 December) and Kingston, Jamaica (9-10 December), where stakeholders involved in ship-related wastes in ports received information on regulations and best practices. They used the information to draft their own port waste management plans.

Regional training on Port State Control (PSC) on MARPOL Annex V was held in Maceio, Brazil (4-6 December), for PSC Officers from Brazil, Argentina, Colombia, Peru, Ecuador, Panama and Costa-Rica. The training includes theoretical and practical aspects, including a mock PSC inspection on board a ship. A similar activity was organized in Kingston, Jamaica (11-13 December) with national participants and PSC officers.

Public officials from 11 Pacific Island countries enhanced their capacity to implement IMO conventions at a regional workshop in Fiji (12-14 November). Organized by IMO and SPC under the SMART-C Leaders Project, the event focused on IMSAS audit findings, CAPs, and compliance with the III Code, promoting regional cooperation and effective maritime governance.

Waste dumping at sea: New project to help prevent marine pollution

Education and collaborative research are at the heart of a new project aimed at promoting implementation of the London Protocol (LP), which prohibits dumping at sea. The SMART-C LC/LP project will focus on building capacity to implement the provisions of the LP treaty and enhance protection of the marine environment.

Ukraine explores accession to IMO oil spill response Convention

Ukraine received support for accession to the OPRC Convention through a feasibility study conducted virtually (1 October-30 November). The study evaluated Ukraine's legislative framework, institutional capacity, and resources for oil pollution preparedness and response, aimed at developing a roadmap for accession to the Convention, while identifying barriers to implementation.

Caspian Sea States bolster regional cooperation on oil spill response

Caspian Sea governments gathered in Aktau, Kazakhstan (8-10 October) to update and finalize a draft regional action plan for responding to major oil spills through the "Aktau Protocol Plan" under the Tehran Convention. Delegates tested the plan and assessed the implementation of regional protocols through a table-top exercise and by using the RETOS tool.

Tackling transboundary oil spills in the Gulf of Thailand

Officials from Cambodia, Thailand, and Viet Nam, alongside industry representatives, participated in an IMO workshop in Bangkok, Thailand (19-21 November) to finalize regional guidelines for the use of chemical dispersants in responding to oil spills in a transboundary setting. Discussions emphasized regional collaboration, national strategies, and compliance with the OPRC Convention.

Twenty African countries gathered in in Lomé, Togo (25-28 November) for the 10th Regional Conference of the Global Initiative for West, Central and Southern Africa (GI WACAF). The event highlighted specific needs requiring IMO assistance, including improving national response systems; updating oil spill contingency plans; developing guidelines; and enhancing cooperation.

Cuba gears up to join ballast water management Convention

Cuban officials participated in a national workshop in Havana, Cuba (22-24 October), aimed at strengthening Cuba's capacity for the ratification, effective implementation and enforcement of the Ballast Water Management (BWM) Convention. The training covered the technical aspects of the BWM Convention and related Guidelines, compliance monitoring, enforcement for port State control, and risk mitigation.

Kenya advances efforts to curb dumping of wastes at sea

A national workshop in Mombasa (2-4 November) brought together more than 25 senior officials from diverse government agencies to discuss the legal, technical and administrative aspects related to applying the London Protocol (LP) in Kenya as a legal framework for marine pollution management, including possible barriers to implementation.






Project on Port Security and Safety of Navigation in Eastern & Southern Africa and the Indian Ocean: Regional and national workshops

- Key maritime agencies in Tanzania upgraded their skills in port security planning, through a training workshop in Dar es Salaam (30 September-4 October). Participants learned to develop and implement Port Facility Security Plans (PFSPs), to help protect the Port of Dar es Salaam, Tanga, Mtwara and Zanzibar from risks such as terrorism, smuggling, and piracy.

- A security assessment of the Port of Luanda (21-25 October) was carried out with the assistance of the Agência Marítima Nacional (AMN), gathering 28 participants from various organisations. The assessment identified key assets and potential threats and prioritised countermeasures. The resulting risk register, a first for the Port of Luanda, will form the basis for preparing Port Security Plan for Luanda. Explore Port of Luanda
- A national workshop for Port Facility Security Officers (PFSO) was held in Luanda, Angola (28-30 October). It covered the development and implementation of a port facility security plan; assessment of security risks; port facility inspections; security equipment and systems; and security awareness and vigilance. This was followed by a national workshop on Security awareness for personnel without security duties (31 October). Explore Port Security project
- A national workshop on the integration of international maritime security instruments into national legislation was held in Luanda, Angola (4-8 November). The aim was to assist the Government in the domestication of international IMO instruments related to port security and safety, particularly SOLAS





- IMO delivered a national workshop on ISPS Code for 27 participants from main ports in Madagascar (4-8 November), including port facility security officers, access control officers, and representatives from Gendarmerie Nationale and Immigration agencies. The training was based on IMO model course 3.24 on Security Training for Port Facility Personnel with Designated Security Duties. Read full article ↗
- A national workshop on Port State Control in Toamasina, Madagascar (25-29 November), helped 22 participants, including 14 PSCOs, to improve their capacity and knowledge about the application of control and compliance measures under SOLAS Convention, specifically Chapter XI-2 on special measures to enhance maritime security. - IMO conducted a national tabletop exercise followed by a workshop on National Maritime Security Committee in Moroni, Comoros (9-12 December) to ensure coordination and cooperation between government ministries and agencies to enhance maritime and port security. Read full article
- IMO delivered a workshop in Port Louis, Mauritius (9-13 December) for 25 senior personnel in charge of the implementation of the port facility security plans. Participants enhanced their knowledge and skills required to perform their duties in accordance with provisions of the SOLAS Chapter IX-2 and the ISPS Code. Read full article

Red Sea Project

Regional Programme for Maritime Security in the Red Sea Area, funded by the European Union

Series of workshops held to promote safety and security for participating countries.

IMO delivered a national train-the trainer workshop for port facility security officers at the Djibouti Regional Training Centre (DRTC) (27-31 October). The training engaged port facility security officers, training officers, port security staff, and facility managers in developing and implementing robust port security frameworks to protect against security threats. - To continue strengthening information sharing and fostering enhanced cooperation on maritime security challenges in the Red Sea area, IMO contributed to the discussions held at the UNODC-led Maritime Law Enforcement Forum (4-6 November), aimed at addressing challenges and exploring opportunities for improving maritime domain awareness.

- IMO continued its maritime security capacity building efforts in Somalia at the port of Bossaso (12-14 December), in collaboration with EUCAP Somalia. The training focused on port facility security assessments to develop a comprehensive port facility security plan to meet ongoing security threats in the region, under the framework of the EU-funded Red Sea Project.
