1 In accordance with the reporting requirements approved by the Technical Cooperation Committee (TCC), at its sixty-second session in June 2012, the Secretariat submits an annual report on the Organization's Integrated Technical Cooperation Programme (ITCP). Thus, this annual report for 2023 records the results of ITCP implementation in 2023, the second year of the 2022-2023 biennium, as well as information on the implementation of thematic long-term projects during 2023.

2 The annual report is structured in two annexes which distinguish between the implementation results in the field and the financial delivery outcomes. The complete annual report for 2023, therefore, comprises the two segments under the annexes listed below:

- .1 annex 1 a synopsis of ITCP achievements and thematic long-term projects in 2023, with summaries and statistics of the ITCP activities delivered, including an appendix detailing the individual activity results of ITCP regional and global programmes; and
- .2 annex 2 an overview of the financial resource delivery of the ITCP and thematic long-term projects supported by statistical analysis, which displays long-term delivery trends, a profile of donor contributions to report the



resources expended,^{*} as well as resource and expenditure data illustrated by region and maritime discipline. The appendix to annex 2 provides a list of expenditure against each programme/project delivered in 2023.

3 The preparation of annex 2 is dependent on the receipt of the audited financial figures, usually provided by the end of March, which provide the baseline data for expenditure analyses. For that reason, annex 2 is submitted independently under document TC 74/3/Add.1.

Action requested of the Committee

4 The Committee is invited to consider the attached Annual Report for 2023 and make such comments and decisions as it deems appropriate, which will be taken into account in the further development of technical cooperation activities.

For the purposes of budgeting and implementation of TC activities, the TC Fund is considered a "donor entity" within the TC programme management framework.

INTRODUCTION

1 IMO technical cooperation activities, including the Integrated Technical Cooperation Programme (ITCP), are designed to assist developing countries¹ to effectively implement international maritime rules and standards in a harmonized manner and in accordance with IMO's global mandate "to promote safe, secure, environmentally sound, efficient and sustainable shipping through cooperation". Thus, the ITCP is developed in response to the technical assistance needs of Member States and its implementation addresses IMO's technical cooperation objectives of strengthening regional maritime capability and promoting maritime development across the globe.

2 The ITCP structure is an integrated framework of regional and global programmes, which is planned and presented to the Technical Cooperation Committee (TCC) for approval each biennium. The annual programmes are planned through Programme Implementation Documents (PIDs) and are ready for delivery at the beginning of each calendar year. Methodical planning ensures the relevance, transparency, effectiveness and efficiency of the technical assistance provided.

3 In addition to the ITCP, IMO also provides technical assistance through thematic long-term projects, which are delivered using external funds obtained under IMO's resource mobilization strategy. These projects address global challenges, such as the reduction of greenhouse gas emissions and the enhancement of maritime security and safety, and are delivered with the support of national, regional and global stakeholders and strategic partners.

4 The year 2023 marked a further increase in technical cooperation activities' implementation levels for IMO following the impact of the COVID-19 pandemic. The blended delivery approach of remote and physical implementation remained during 2023 to sustain opportunities for efficiency where appropriate.

5 The results of the ITCP delivery in 2023 represent the collective effort of some 41 IMO implementing officers and their support staff at the Headquarters in London and in the Regional Presence Offices (RPOs), together with external partners and regional organizations.

6 While this report provides particulars of the activities delivered under the ITCP and thematic long-term projects, further operational details on specific elements of technical cooperation are submitted to TCC for consideration under separate agenda items. Where relevant, reference to such documents is made throughout the text of this report.

7 In the interests of clarity, the information in this report addresses expenditure on IMO's technical cooperation activities only. Full financial information will be available in the financial reports under agenda item 5(b) of C 132.

PROGRAMME OVERVIEW AND EXECUTION

Overview of ITCP delivery in 2023

8 ITCP activities delivered in 2023 covered a wide range of subject matters under the maritime disciplines of maritime safety, security, facilitation, legislation, marine environment protection, Member State audit, maritime training and general maritime sector.

¹ The designations "developing countries" and "developing regions" are intended for statistical convenience and do not express a judgement about the stage reached by a particular country or area in the development process.

9 The ITCP considered the objectives of the approved strategic directions and outputs of the *Revised Strategic Plan for the Organization for the six-year period 2018 to 2023* (A.1149(32)), as well as the Secretary-General's vision and policy directions on technical cooperation matters. Due regard was also given to the United Nations (UN) 2030 Agenda for Sustainable Development (2030 Agenda), regional and subregional strategies and the findings of the IMO Member State Audit Scheme (IMSAS) audits. In this respect, particular emphasis was placed on strengthening institutional capacities and human resource development in the regions.

10 To supplement the regional programmes, the global programmes are focused on addressing specific technical and emerging issues at a global level. This flexible structure of the ITCP provides a mechanism for funds to be targeted across a spectrum of subject matters. Member States gain from the symbiosis of regional and global programmes, which allows activities to be delivered to those countries which need them most, and also impacts positively on the sustainable development of the maritime community as a whole.

11 IMO's ability to deliver technical assistance was enhanced through formal partnership agreements with many of its Member States and various international and regional organizations (see document TC 74/4(a)). This demonstrates the value of continuing to develop formal partnerships to promote IMO's technical cooperation agenda.

A summary of all deliverables carried out under the programmes is presented in the tables and charts at the end of each regional and the global overview section. Further details on the implemented activities, including outputs and participating countries, are presented in the appendix to this annex.

13 Details on the deliverables carried out under the thematic long-term projects in 2023 can be found in paragraphs 87 to 125.

Aggregates for 2023

14 Although IMO endeavours to deliver all activities programmed each year, it is inevitable that circumstances arise which necessitate the cancellation or postponement of activities. Reasons include requests by a host country, security concerns, the political situation, weather events, epidemic, etc. For this reason, the delivery of programmed activities is unlikely to reach 100% in any given year.

In 2023, 206 activities were delivered out of a total of 276 programmed activities, a delivery rate of 75%. This is a 5% increase in the number of activities delivered in 2022 (181 activities were delivered out of 258 programmed), which was a delivery rate of 70%. In addition to the 206 activities completed in 2023, another 23 activities commenced late in 2023 and will be completed in 2024. While these activities are not included in the 2023 figures for this annual report, they represent the actual work effort of the Secretariat in the 2023 calendar year and are worth noting.

16 Of the 206 activities delivered in 2023, 13 were advisory and needs assessment missions, an increase from 8 in 2022; and 102 were national, regional and global training courses, an increase from 87 in 2022. Ninety-one other activities were also delivered during 2023, including development and translation of training materials; meetings of heads of maritime administrations; conferences and other technical assistance, compared to 86 similar activities carried out during 2022.

17 IMO sponsored a total of 176 fellowships in the maritime sector in 2023. While this number is lower than the one recorded in 2022, which was particularly high due to the fact that

additional courses were completed in 2022 to make up for the restrictions during the COVID-19 pandemic, it is higher compared to pre-pandemic numbers. Thirty-six of the 176 fellows qualified through the two IMO global maritime training institutions – the World Maritime University (WMU) and the IMO International Maritime Law Institute (IMLI) – while 140 were sponsored by both IMO and donors to participate in courses delivered by other maritime training institutions, such as the Institut Portuaire d'Enseignement et de Recherche du Havre (IPER) in Le Havre, France, and the International Maritime Safety Security and Environment Academy (IMSSEA) in Italy.

18 Additionally, approximately 2,590² persons worldwide were trained through attendance at national and regional training workshops and seminars, an increase from the 2,028 trained in 2022. A further 657 senior officials attended events in 2023 aimed at developing and harmonizing regional strategies on maritime technical issues.

19 Table 1 displays the number of different types of ITCP activities delivered, as well as the number of trainees and fellows during 2023. Chart 1 indicates the number of activities and trainees (excluding fellows) by maritime discipline and chart 2 shows the geographical distribution of IMO-sponsored fellowships. For details on the specific beneficiary countries of fellowships, please refer to the appendix. If there is a number indicated in the "Fellows" column for a particular activity, the countries can be found in the corresponding "Participating Countries/Territories" column.





Chart 1: ITCP total activities and trainees by maritime discipline, 2023





Gender reporting for 2023

20 The IMO Women in Maritime (WIM) programme has promoted opportunities for women in the maritime sector for more than three decades. Document TC 74/9 reports in more detail on this programme, but in an effort to mainstream gender equality, gender statistics of ITCP activities are now also included in the Annual Report. In this regard, since 2018, participants at IMO-sponsored trainings and workshops have been asked to include their gender when they register, with the options of "male", "female" and "not reported". This enables the Organization to compile data related to gender and, over time, to build a picture of the "gender participation" trends within IMO's technical cooperation work. As per chart 3 below, 28% of ITCP participants were female, which is slightly lower than the 32% recorded in 2022. As can be seen from the further breakdown in chart 4, while females continue to represent a positive percentage of 72% in the fellows category, the percentage of female trainees has decreased compared to the 28% of 2022. The percentage of female strategy officials has, however, slightly increased from the 38% recorded in 2022.





Chart 3: 2023 ITCP participants by gender

OVERVIEW OF REGIONAL PROGRAMMES FOR 2023

Africa: regional overview 2023

IMO continues to focus on the delivery of the ITCP in the countries of the Africa region with 16% of them categorized as a small island developing State (SIDS) and 60% as least developed countries (LDCs), notably through the significant role played by the three Regional Presence Offices located in Abidjan, Côte d'Ivoire; Accra, Ghana; and Nairobi, Kenya. The Regional Coordinators implement activities, provide support and contribute to the long-term goal of strengthening institutional and human capacities in Africa for the effective administration and oversight of the continent's maritime and port sectors and by so doing, ensure compliance with relevant IMO instruments as well as maintain high safety standards. During the period under review, the Global Search and Rescue (SAR) Plan continued to receive support through collaboration with the International Maritime Rescue Federation (IMRF). Several activities were delivered, both in person and virtually, for On Scene Coordinators, (IAMSAR Vol. III) and on SAR Administration and Management (IAMSAR Vol. I) A regional meeting for the five Africa SAR regions was also delivered. In addition, two regional workshops for women in SAR were delivered in Morocco and Kenya, respectively.


Furthermore, the Africa region benefited from a range of capacity-building activities which focused on facilitation of maritime traffic, port State control, marine casualty and incident investigation, assessment and examination for instructors, assessors and administrators based on the 1978 Standards of Training, Certification and Watchkeeping for seafarers (STCW) Convention, as amended, the carriage and handling of dangerous goods (IMDG and IMSBC Codes), sensitization on IMO mandatory container weight verification requirement (CWV), and the general drafting of national legislation to implement IMO conventions. Moreover, two needs assessment missions on STCW were held in Cameroon and Sierra Leone, and one needs assessment mission on maritime single window was held in Benin. The Single Window for Facilitation of Trade (SWiFT) project in the port of Lobito, Angola, on the facilitation of international maritime traffic, was completed in November 2023. This project was supported by Singapore and the platform SWiFT may be considered for adoption by other Member States, when appropriate, to fulfil the reporting requirements of the Convention of Facilitation of International Maritime Traffic (FAL Convention).


25 Workshops and training activities on marine environmental sustainability were carried out in the region to increase awareness on the implementation of the Ballast Water Management (BWM) Convention; the development of oil spill contingency plans; International Convention for the Prevention of Pollution from Ships (MARPOL) Annex I-V, and MARPOL Annex VI. In the spirit of partnership development, IMO and IPIECA, under the Global Initiative for West, Central and Southern Africa (GI WACAF), continued to strengthen the oil spill response capacity and capabilities of countries in West and Central Africa subregion.

As part of IMO's support to maritime development in Africa, the Organization participated in and sponsored delegates to attend the sixth Conference of the Association of African Maritime Administrations (AAMA), held in Kenya, in May 2023.

Arab States and Mediterranean: regional overview 2023

27 IMO, through its technical cooperation activities, continued to support Member States in the Arab States and Mediterranean region during 2023. With the objective of raising awareness and promoting ratification of the BWM Convention and related guidelines, and to strengthen regional capacity for effective implementation and enforcement of the Convention, IMO and the Regional Marine Pollution Emergency Response Centre for the Mediterranean Sea (REMPEC) jointly organized a regional workshop and meeting on harmonized procedures on the BWM Convention in the Mediterranean region, attended by 29 participants from 16 countries.

Furthermore, IMO conducted a regional training course on marine casualty and incident investigation, attended by 24 participants from eight Member States. The course objective was to facilitate the development of institutional capacities and human resources in the field of casualty investigation within the regional administrations in North Africa and the Middle Eastern region.

Two national workshops on flag State implementation and port State control were also implemented and attended by 34 participants of the Saudi Arabia maritime administration.

30 Subsequent to the decision of TC 72, and following the endorsement of C 128, IMO signed a Memorandum of Understanding (MoU) with the Government of the Arab Republic of Egypt, for the hosting of the Regional Presence Office for the Arab States in the Middle East and North Africa (MENA) region in Alexandria, Egypt, for the implementation of IMO's technical cooperation activities.




Chart 6: Activities and trainees in Arab States and Mediterranean, 2023

Asia and Pacific: regional overview 2023

31 The IMO Regional Coordinator for East Asia and the IMO Technical Cooperation Officer at the Pacific Community (SPC) for the Pacific region continued their usual interaction and support to Member States in their respective regions, including advice and assistance with the implementation of national and regional activities. Consultations continued with the Government of the Republic of Fiji for the finalization of the MoU for the establishment of an IMO RPO. Furthermore, the support from Australia (financial), Papua New Guinea (in-kind and financial) and Solomon Islands (in-kind) contributed to the establishment of the RPO in the Pacific Islands with the recruitment of two Junior Professional Officers (JPOs) from Papua New Guinea and Solomon Islands, respectively, to support the transition.

32 The Secretariat participated in regional meetings, such as the twenty-third session of the Asia-Pacific Heads of Maritime Safety Agencies (APHoMSA) Forum, held in Australia and hosted by Mongolia; the forty-fourth and forty-fifth sessions of the Association of South-East Asian Nations Maritime Transport Working Group (ASEAN-MTWG), held in Viet Nam; the fifth Pacific Regional Energy and Transport Ministers' meeting, held in Vanuatu; and meetings of the United Nations Economic and Social Commission for Asia and the Pacific (UN ESCAP). Participation in such meetings continued to provide opportunities to identify the real needs of Member States in the region, with their direct input.


33 During 2023, a new approach was initiated towards the conduct of no-blame safety investigations through the delivery of two national foundation courses on marine casualty investigation for IMO Member States (abridged programme based on IMO Model Course 3.1). This approach was supplemented by a five-day practical hands-on experience in conducting investigations. Moreover, the study to address the safety and energy efficiency of domestic passenger ships in the Philippines was finalized. As a result, further consultations will be initiated with the World Bank Group to determine how to extend assistance to the Philippines to implement the recommendations of the study, including consideration for projects to create safe and green corridors and to provide a road map to enhance the safety of passenger ships on domestic voyages.

Additionally, numerous consultations were held with the Maritime Just Transition Task Force (MJTTF) that led to securing a grant from the Lloyds Register Foundation towards a project entitled "A holistic approach to the enhancement of domestic ferry safety", in collaboration with IMLI and WMU.




Chart 8: Activities and trainees in Pacific Islands, 2023

Western Asia and Eastern Europe: regional overview 2023

35 The regional programme provided technical assistance to Member States focusing on institutional capacity-building in the field of facilitation of maritime trade, search and rescue and cooperation in combating oil spills, particularly along the Adriatic Sea coastline. With the amendments to the FAL Convention (maritime single window) coming into force in January 2024, which marks a milestone in the acceleration of digitalization in shipping, priority was given to streamlining procedures to clear the arrival, stay and departure of ships and greatly enhance the efficiency of shipping within the maritime domain of the region.


Having received multiple requests from the Black Sea littoral States, the regional programme supported the continuation of training on search and rescue mission coordination. This has become a well-established method to prioritize the saving of lives at sea in the Black Sea subregion.

37 Throughout the year 2023, the programme continued to support cooperation with the EU Transport Community Treaty (TCT), REMPEC and the European Maritime Safety Agency through active participation in regular meetings of the Technical Committee on Waterborne Transport and Multimodality for the benefit of the Member States from the Western Balkans subregion. A regional Conference was organized in Montenegro on World Maritime Day in September 2023 to mark the fiftieth anniversary of the adoption of MARPOL Convention in cooperation with EU TCT.

Latin America and Caribbean: regional overview 2023

³⁸Following the three-year pilot thematic programmes approved by TC 71 (TC 71/16, paragraph 3.34.1), and taking into account the experience gained in the previous regional needs assessments in the Operative Network for Regional Cooperation among Maritime Authorities of Central America and Dominican Republic (ROCRAM-CA) Member States, (SAR, FAL, greenhouse gas (GHG), Seafarers' Training, Certification and Watchkeeping (STCW)) the Central American region focused its efforts at the national level on the FAL and STCW Conventions. In parallel, regional needs assessments were initiated regarding the International Convention on Oil Pollution Preparedness, Response and Cooperation (OPRC) and the London Protocol and London Convention.

39 In addition to the above-mentioned thematic programmes, in line with the IMO Capacity-Building Decade 2021-2030 Strategy, through a new process called "Strategic approach", a model was developed to assist countries in the adoption and implementation of IMO instruments and amendments.

40 With the aim of assessing the needs for the implementation of measures to facilitate international maritime traffic, including their preparation to implement electronic data exchange and the concept of a single window to support ship clearance processes in ports, a second phase of the regional FAL needs assessments was initiated in 2023 and is underway in Latin American countries including Argentina, Brazil, Chile, Colombia, Ecuador, Peru and Uruguay.

41 With a view to responding to the Spanish speaking Member States' request for technical assistance, IMO, in collaboration with WMU, has initiated an e-learning course in Spanish on biofouling management entitled: "Introduction to Marine Biofouling: Impacts and Management of Risks" expected to be completed in the first quarter of 2024.

42 Additionally, within the framework of the MoU between IMO and the Directorate-General of the Merchant Navy of the Kingdom of Spain to promote technical cooperation, signed in October 2019, two distance training courses, on the uniform implementation and control of the 0.50% sulphur limit under MARPOL Annex VI (two editions) and on the implementation of the Cape Town Agreement, were delivered to participants across the Latin American region.

43 Under the same MoU, IMO financed the travel for one official from Guatemala to participate in the "Introduction to standard marine communication phrases (SMCP)" delivered by the Jovellanos Integral Maritime Safety Centre in Spain. The participant attended the course in a blended format. The training provided an in-depth understanding of the SMCP, equipping the participant with essential communication skills for maritime operations.

44 Considering the recently adopted *Revised IMO Strategy on Reduction of GHG Emissions from Ships*, IMO, in collaboration with the Government of Chile, organized the Regional Conference on Green Shipping in Latin America, held in Santiago, Chile, which served as a key platform to address the urgent need for decarbonization in the shipping industry and the national workshop "Towards a more sustainable shipping", held in Valparaiso, Chile, which aimed to raise awareness about IMO's Green Hydrogen project in Latin America, scheduled to be launched in 2024.

45 Two activities were undertaken to address Cuba's request for technical assistance:

- .1 a national workshop on ratification and implementation of the International Convention on the Control of Harmful Anti-fouling Systems on Ships (AFS Convention), which resulted in progress towards ratification of the AFS Convention by Cuba; and
- .2 a national training course on OPRC levels 1 and 2, where personnel were trained in oil pollution response.

In an effort to boost marine casualty investigation capabilities across the Caribbean region, a comprehensive assessment was undertaken in Antigua and Barbuda, the Bahamas, Belize, Haiti, Jamaica, Saint Kitts and Nevis and Saint Vincent and the Grenadines. This evaluation, at both regional and national levels, provided insights into the strengths and areas of opportunity of each country's approach. Through collaborative efforts and strategic planning, significant progress was achieved in enhancing the region's capacity for investigating and reporting marine incidents.

47 Additionally, in the Caribbean region, a national workshop in the Bahamas supported the implementation of the BWM Convention. This workshop aimed to increase awareness and understanding of effective implementation and enforcement measures under the BWM Convention, as well as the related guidelines. It also facilitated the expansion of a network of trained experts in BWM and control.


48 To highlight the accomplishments within the maritime single window framework, a presentation was delivered showcasing Antigua and Barbuda's implementation at the International Association of Ports and Harbors (IAPH) World Ports Conference in Abu Dhabi,

November 2023. A consultant from Antigua and Barbuda collaborated with the IMO Secretariat to introduce the project, originally initiated by Norway, to the conference attendees, marking a significant step towards enhancing maritime efficiency and coordination.




Chart 11: Activities and trainees in Caribbean, 2023

OVERVIEW OF GLOBAL PROGRAMMES FOR 2023

The **Technical Advisory Services programme**, through its flexible mechanism, 49 aims to respond to emergency technical assistance requests, such as those related to marine pollution or maritime safety incidents. It also provides ad hoc legal and/or technical advisory missions to assist Governments with addressing requests essential to the effective implementation of global maritime standards. In 2023, the programme provided support to the UN Operations, through the provision of technical guidance and expertise in response to a possible oil spill incident in respect of the FSO SAFER, as well as advice on outstanding issues to be addressed and recommendations.

Under the programme to Support the Special Shipping Needs of SIDS and LDCs, 50 work continues towards a comprehensive assessment and profiling of IMO Member States that are categorized as SIDS (38) and LDCs (34). In 2023, in-depth thematic analysis to profile the specific needs of SIDS and LDCs was progressed, with a view to identifying, articulating and addressing common findings, root causes and highest priority shipping needs.

51 The programme also delivered activities in support of the Pacific and Africa regions, which have the highest concentration of IMO Member States that are categorized as SIDS and LDCs, respectively. These activities included:

- .1 support to the participation of officials in the twenty-third session of the Asia-Pacific Heads of Maritime Safety Agencies (APHoMSA) Forum, as well as in the Entry-level Search and Rescue Operation (SARO) course and advanced SARO refresher course, both held in June 2023:
- .2 review of the Pacific Regional Framework for Action on Transport Services (FATS) 2011-2022; and
- .3 support to an Africa Regional Task Force Meeting under the GloLitter Partnerships project, held in Kenya in November 2023.

52 The **Women in Maritime programme**, which is a technical cooperation priority for IMO under the TC Framework, has as its key objective the achievement of gender equality and empowerment of women within the maritime sector, through the fostering of an inclusive environment which supports women's growth, harnesses their talent, and recognizes their contributions. More detailed information regarding the work carried out under the programme in 2023 can be found in document TC 74/9.

53 The **Capacity-building and Training programme** continues to reinforce national and regional maritime capacities through human resources development. In 2023, it funded fellowships for maritime specialists to follow post-graduate studies at WMU and IMLI (see documents TC 74/10(a) and TC 74/10(b), respectively) and to attend short- and medium-term courses at other training institutions (see document TC 74/10(c)). The programme also supported the governance of WMU and IMLI, as well as the delivery of in-person or virtual lectures, including the delivery of a seminar at IMLI by WMU faculty staff.

54 This programme also funded training of officials in the formulation of National Maritime Transport Policies (NMTPs). This included delivery of a workshop in Belize as a means to support sustainable maritime development and ensure effective implementation of its international obligations and responsibilities as a flag, port and coastal State. Additionally, the programme sponsored a workshop on the general principles of drafting national legislation to implement IMO conventions through the participation of government lawyers, legislative drafters and policy advisers from several countries, thereby raising awareness of IMO instruments and reinforcing the required knowledge and skills to draft national legislation to implement IMO conventions. Through a partnership arrangement with the Republic of Korea, funding was also provided for an onboard practical training programme hosted in Busan, which assisted a number of cadets from Africa and Ukraine in meeting the minimum standard of seagoing experience in accordance with the STCW Convention.

55 With regard to e-learning courses, funding under this programme was provided for the development of training material and course content for the following maritime themes:

- .1 BWM Convention;
- .2 an introductory course to counter wildlife trafficking in the maritime supply chain (IWT);
- .3 the London Protocol;
- .4 maritime single window; and
- .5 translation into French of the OPRC introductory e-learning course.

56 Support costs for one Junior Professional Officer (JPO) recruited under the gratis modality scheme were also covered under the programme.

57 The global programme on **Reducing Atmospheric Emissions from Ships and in Ports and Effective Implementation of MARPOL Annex VI and the Initial IMO GHG Strategy** was designed to assist Member States with the ratification and effective implementation of MARPOL Annex VI, the *IMO Strategy on Reduction of GHG Emissions from Ships* (the IMO GHG Strategy), the consistent implementation of IMO 2020 and the sulphur emission control areas (SECAs).

58 During 2023, the programme, through national and regional activities, continued to raise awareness on the need to decarbonize international shipping. Notably, it provided an

understanding of the decarbonization pathways and the zero and near-zero fuels and technologies that can be deployed, as well as providing good momentum for Member States from Africa, Arab States, Asia and the Pacific to develop their National Action Plans (NAPs) on reducing GHG emissions from ships, in line with resolution MEPC.327(75). A number of ITCP regional programmes also supported implementation of the IMO GHG Strategy, with a focus on fostering synergies between the decarbonization of international shipping and the green energy transition, including incentivizing investments in the production of sustainable fuels and associated infrastructure.

In February 2023, the programme supported a regional roundtable in Fiji on improving the availability of maritime transport costs data in the Pacific, organized by IMO, the Secretariat of the Pacific Regional Environment Programme (SPREP) and the Maritime Technology Cooperation Centre (MTCC) Pacific. The roundtable discussed what a "just and equitable transition" towards low-carbon shipping could mean and how this could accelerate progress towards achievement of a number of Sustainable Development Goals (SDGs), notably, SDG 7 (affordable and clean energy), SDG 13 (climate action), SDG 14 (life below water) and SDG 17 (partnerships for the goals).

Additionally, the programme continued to support relevant UN system meetings and activities on implementation of the aforementioned UN SDGs, as well as the 2023 World Maritime theme "MARPOL at 50 – Our commitment goes on". In this regard, in November 2023, the programme funded IMO representation at the fourth Maritime SheEO Conference 2023, presenting on the 3Ds in shipping – decarbonization, digitalization and diversity. Participants were apprised of the positive impact on the environment since the adoption of MARPOL, the primary global treaty for the prevention of pollution of the marine environment by ships from intentional, operational or accidental cause.

61 Moreover, within the margins of the UN Climate Change Conference (COP 28) held in Dubai, United Arab Emirates, from 30 November to 12 December 2023, the programme supported attendance at COP 28 and provided an opportunity to report on the progress made on the Organization's work on the reduction of GHG emissions. In particular, the adoption of the 2023 IMO GHG Strategy to the fifty-ninth session of the United Nations Framework Convention on Climate Change (UNFCCC) Subsidiary Body for Scientific and Technological Advice (SBSTA), as was also set out in IMO's contribution to the first Global Stocktake.

Moreover, the Secretariat co-organized two COP 28 side-events and participated in a number of other side events (refer document MEPC 81/INF.10). A COP 28 side event (2 December 2023), organized by IMO in collaboration with the International Civil Aviation Organization (ICAO) and the International Renewable Energy Agency (IRENA), explored how policies developed through ICAO and IMO, two specialized agencies of the UN, are promoting the clean energy transition for international aviation and shipping, in support of the Paris Agreement temperature goal. On 9 December 2023, IMO co-organized a side-event with the United Nations Conference on Trade and Development (UNCTAD) and IRENA on the development of IMO's mid-term GHG reduction measures. Two panels representing different Governments' and industry's views provided on both the GHG pricing mechanism and GHG fuel intensity proposals currently being developed and assessed. Refer also to: IMO at COP 28

In December 2023, IMO, in cooperation with the Maritime Just Transition Task Force Secretariat, embarked on a long-term project entitled "Baseline Training Framework for Seafarers in Decarbonization", aimed at developing training materials to help maritime education and training institutions prepare seafarers for zero or near-zero emissions from ships in line with the 2023 IMO GHG Strategy. Thus, with a view to helping the global shipping industry decarbonize and ensure that training on decarbonization is available to seafarers who are on the frontline of the shipping industry. Once developed, the Baseline Training Framework for Seafarers in Decarbonization will be first tested out in Asia through a programme led by the World Maritime University, with support from MTCC Asia and other partners.

64 The global programme on the **Enhancement of Maritime Security** continues to focus on targeted assistance to respond to increasing threats posed by terrorism, piracy, armed robbery, smuggling and other illicit activities at sea, and take measures that protect ships and ports. The programme, inter alia, responds to the International Convention for the Safety of Human Life at Sea (SOLAS) Contracting Governments' requests related to the implementation of the requirements set out in SOLAS chapter XI-2, the International Ship and Port Facility Security Code (ISPS Code) and other IMO maritime security measures, such as the implementation of the Long Range Identification and Tracking (LRIT) system, the implementation of the Convention for the Suppression of Unlawful Acts against the Safety of Maritime Navigation (SUA Convention), and security aspects of the FAL Convention

In 2023, 18 activities were delivered under the programme organized and/or co-organized with development partners for Designated Authorities, port and ship security officials, managers, UN and other implementing partners with a shared interest in enhancing maritime security worldwide, including facilitating meetings with industry stakeholders. These activities included, among others, training on the ISPS Code for Designated Authority and Port Facility Security Officers, National Port Facility Security Auditors, National Maritime Security Risk Register, Introduction to Passenger and Baggage Screening and Searching, Advanced Drills and Exercises, train-the-trainer workshops for IMO consultants and security needs assessments.

66 The programme has continued to significantly expand the range of training offered to Member States to target both national maritime security governance frameworks and port and ship level security. In addition to the new training available under the Whole of Government Approach to Maritime Security, Maritime Domain Awareness and the Introduction to Maritime Passenger and Baggage Screening and Searching, the Secretariat is developing new training in Insider Threat, Security Culture and Practical Maritime Person and Baggage Screening and Searching.

67 The programme continues to support counter-piracy capacity-building and global implementation of measures to suppress piracy through the coordination of initiatives among stakeholders, including facilitating meetings with industry and Interregional Coordination Centre representatives. In 2023, the global number of incidents increased, with 150 incidents of piracy and armed robbery against ships reported to the Organization, compared with 131 incidents in 2022. The regions most affected are Straits of Malacca and Singapore (85), West Africa (22), South China Sea (14) and South America (Pacific) (14).

68 The programme continued with the commitment to increase the number of women in maritime security activities by promoting the nomination of women in workshops, seminars, and training by providing additional funding. In 2023, IMO sponsored 29 female candidates from developing countries to attend a Maritime and Port Security course from 12 June to 22 July at the Galilee International Management Institute in Nahalal, Israel. The course addressed the various strategic, legal, logistical, and technological aspects of maritime security, including the implementation of port facility security assessments (PFSAs), and the development of port facility security plans (PSFPs) and procedures.

69 Finally, in 2023 the programme supported IMO representation in the UN Counter-Terrorism Committee Executive Directorate (CTED) port visits to Canada, Chile, Ecuador, the Republic of Korea and Thailand, in order to assess their compliance with relevant international security instruments, namely SOLAS chapter XI/2, the ISPS Code and the SUA Convention.

The global programme on the **IMO Member State Audit Scheme** continued successfully to support Member States in training new auditors and preparing for the audits. Effective implementation of resolution A.1067(28) on *Framework and Procedures for the IMO Member State Audit Scheme* was supported through the delivery of five global, regional, and sub-regional events across developing regions and resulting in 80 well trained experts in IMSAS.

71 During 2023, the programme facilitated participation of an observer from Mexico to the Audit in Argentina to assist the national maritime administration in preparing and following up on their IMSAS audit.

The programme also funded the development of the IMO e-learning course for auditors, which was launched in October 2023 and is publicly available via the IMO e-learning platform. The course is also being delivered in the format of a 'blended learning' training modality where participants must complete the online course before attending the in-person component, which promotes cost-effectiveness and the ability to level up the training content as participants already have the foundation knowledge.

73 Under the **Maritime Development** global programme, technical assistance was provided across the board in the alignment and mainstreaming of the SDGs into national development plans and programmes. It also supported global interventions of the maritime thematic technical cooperation priorities, as agreed by each of the IMO Committees.

On environmental matters, activities were held to promote the London Protocol; to capacitate officials from Bangladesh on the needs and best practices for the set-up and management of a treatment, storage and disposal facility to support the ship recycling industry; to update the Readiness Evaluation Tool for Oil Spills (RETOS) Manual and the International Guide for the Assessment of Oil Spill Response Planning and Preparedness; and to support national and UN inter-agency contingency planning efforts in the event of a possible oil spill from the **FSO SAFER** in Yemen. The IMO Guidelines on the use of chemical dispersants in oil spill response were also published in 2023 with support from this programme.

75 The programme also sponsored participants from nine countries to participate in the International Oil Spill Conference for the Asia-Pacific region (Spillcon 2023) which enhanced participants' knowledge on topics related to oil pollution preparedness and response, with a view to improving their respective technical competencies and developing capacity at the national level.

The programme further supported the social media campaign and similar activities to promote the 2023 International Day of the Seafarer under the theme "Seafarers and their Voyages". Focusing on seafarers and the voyage of shipping will help connect the experience of seafarers with the development of shipping such as technological advancements.

577 Support and facilitation were provided for a lessons learned workshop for Polar Code training programmes held in Argentina in November 2023, which helped identify improvements required in Polar Code training programmes to achieve the goal of competent seafarers in accordance with chapter 12 of the Polar Code.

The programme also provided financial support to a study group to address issues arising from fraudulent registries and registration of ships and measures to prevent and combat the practice, which was coordinated by WMU, with participation from IMLI and UNCTAD. The final report of the study group has been submitted to the Legal Committee (LEG 111/6). 79 On matters relating to port State control MoUs, the programme sponsored trainers of PSCOs from developing PSC regimes to attend specialized training and receive updates on relevant instruments, in particular regarding tankers and PSC inspection techniques in accordance with global standards.

80 Through the support of the programme, work continued on the development, management and maintenance of the IMO Compendium on Facilitation and Electronic Business.

81 The programme also produced a range of promotional materials related to IMO's work, as well as virtual reality materials to raise awareness on marine biofouling.


82 The programme on the **Promotion of the London Protocol (LP)** provides technical assistance to developing countries (including prospective LP Parties) related to the LP. In 2023, the activities continued to target accession to, and implementation of, the LP, as well as the identification and removal of barriers for countries to achieve compliance with ocean disposal agreements as a crucial part of marine pollution management. The year 2023 also marked the accession of Iraq to the LP. The programme also supported the continuing work of relevant Joint Group of Experts on the Scientific Aspects of Marine Environmental Protection (GESAMP) Working Groups 41 and 43.

83 The **IMO Model Courses programme**, which is now managed outside the framework of the ITCP, provides a framework for the development of new, and the revision of existing, IMO model courses, and for managing the production, translation, editing and printing of these courses. In 2023, pursuant to this, two new model courses were published: Passenger Safety, Cargo Safety and Hull Integrity Training (KT146E) and Engine-Room Resource Management (KT717E); and eight revised model courses were published: Fire Prevention and Fire Fighting (KTB120E), Bridge Resource Management (KTB122E), Proficiency in Survival Craft and Rescue Boats (other than Fast Rescue Boats) (KTB123E), Proficiency in Fast Rescue Boats (KTA124E), Advanced Training in Fire Fighting (KTB203E), Security Awareness Training for all Port Facility Personnel (KTA325E), Security Training for Seafarers with designated Security Duties (KTA326E) and Security Awareness Training for all Seafarers (KTA327E).

FINANCIAL SUPPORT FOR THE DELIVERY OF THE ITCP

As will be detailed further in the addendum to this document, the activities under the ITCP are financed through a combination of the TC Fund and donor funding. The table showing the full list of activities programmed in 2023 is shown in the appendix to this document. In the appendix table, there is a column for TC Fund, indicating whether the activity was financed in part or in full by the TC Fund (cell marked "Yes"), whether it was fully funded by donors (cell marked "No") or whether there was no expenditure associated with the activity (cell marked "N/A"). Where a cell is left blank, the activity was postponed or cancelled. Chart 13 below shows the proportion of completed and ongoing activities financed in part or in full by the TC Fund, and those which were fully donor funded.




Chart 13: Proportion of 2023 ITCP activities delivered by source of funding

THEMATIC LONG-TERM PROJECTS

87 In addition to the regional and global programmes under the ITCP, IMO's technical cooperation programme for 2023 included a number of thematic long-term projects. These are delivered using external funds obtained under IMO's resource mobilization strategy.

88 The continuously growing portfolio of long-term projects has been addressing various global challenges that are key for the implementation of the 2030 Agenda and the transformation of the maritime sector to a more sustainable future, with a focus on the maritime needs of developing countries, in particular SIDS and LDCs.

89 Guided by a clear set of outcomes and activities defined by a project results framework that is monitored and evaluated regularly, these projects are delivered with the support of national, regional and global stakeholders and strategic partners. These include governments, industry, non-governmental organizations and other civil society organizations – all vital partners in successful, impactful implementation. These projects also align with the maritime technical cooperation thematic priorities agreed by each of the IMO Committees and the SDGs, and encourage active collaboration and participation between IMO, governmental agencies and other relevant stakeholders.

GHG projects

90 **The Global Maritime Technology Cooperation Centre Network (GMN)** is funded by the **European Union** (EU) (\$11 million). Phase I was successfully completed in March 2022, which aimed to reduce international shipping's GHG emissions. Over the course of six years, Global MTCC Network (GMN) has established five MTCCs in Africa, Asia, the Caribbean, Latin America and the Pacific, with a primary goal of enhancing the human and institutional capacities in maritime administrations and port authorities. The Network has conducted over 90 workshops and conferences and delivered ten pilot demonstration projects. To build on this success, the European Commission has pledged a further €10 million to support GMN Phase II from 2023 to 2027. The focus will be on scaling up the work of the regional centres, with emphasis on facilitating the introduction of portside energy efficiency measures and technologies, as well as retrofitting domestic vessels through pilot demonstrations.

During the reporting period, **IMO GreenVoyage2050** has achieved a number of important outputs, including supporting Solomon Islands in the development of a NAP to address GHG emissions from ships, and undertaking a feasibility study for identified pilot projects in Georgia, Malaysia and South Africa. GreenVoyage2050 also developed and delivered two new workshop packages, one on the Development of a Route-Based Action Plan Methodology in Singapore, and another one on Port Actions for Green Shipping, in Mumbai, India. GreenVoyage2050 has secured additional funding for a Phase 2, which will run from January 2024 onwards, from the Government of Norway (210 million NOK) with additional contributions from Finland, France, Germany and the Kingdom of the Netherlands totalling €450,000. 92 The **Global Industry Alliance to Support Low Carbon Shipping (Low Carbon GIA)**, a public-private partnership established under GreenVoyage2050, launched a new web-based portal on Just In Time arrival, as well as developed and released a video series on CII and EEXI. Low Carbon GIA has also delivered several activities with respect to alternative marine fuels, including undertaking a regulatory mapping exercise, and the development of a glossary of life cycle assessment terminology. Low Carbon GIA also convened a roundtable to discuss chain of custody models for sustainability and lifecycle GHG emissions of marine fuels.

93 The **IMO Coordinated Actions to Reduce Emissions from Shipping (IMO CARES) Project** is funded by the Kingdom of Saudi Arabia (\$1.6 million) and aims to reduce shipping emissions through coordinated actions worldwide. Following a year-long preparatory phase, the project moved to a full-scale implementation phase from 1 April 2023. The project's

objective is to accelerate demonstration of green technologies and their deployment globally, with particular focus on SIDS and LDCs. To achieve its objective, the project is undertaking a Maritime Technology Global Challenge to identify suitable technology solutions. These technologies are focused on portside energy efficiency and the retrofitting of domestic vessels. The solutions identified will eventually undergo pilot demonstrations in Africa and the Caribbean under the GMN II Project. Additionally, the IMO CARES project will produce a detailed technology report, focusing on energy-efficient maritime technologies in developing countries.

94 Within the GHG portfolio, the IMO-Republic of Korea GHG SMART (Sustainable Maritime Transport Training Programme to Support the Implementation of the GHG Strategy) Programme is funded by the Republic of Korea (\$4.5 million), supporting SIDS and LDCs with the implementation of the IMO GHG Strategy via building sufficient human capacity in these countries. This includes development of a comprehensive training programme and post-training monitoring, evaluation and refinement. The GHG-SMART Project represents an innovative way of delivering IMO's training activities since it provides a continued long-term training programme for the participants, over one year. The online Core Training is followed by post training monitoring, evaluation and refinement. Participants undergo classroom training as well as field training. The field training includes visits to the technology development and demonstration sites and major infrastructure facilities that support GHG reduction and energy efficiency. In addition, the two top-performing participants of the programme (one female and one male) are offered fully funded scholarships to study for a Master of Science in Maritime Energy Management at WMU in Malmö, Sweden. In 2023, GHG SMART trained 20 participants from 13 countries from the Africa, Asia, Caribbean and Pacific regions.

95 The third **IMO-UNEP-Norway Innovation Forum** took place on 28 September 2023. The Innovation Forum is a global platform to exchange best practice between competent international policy makers, maritime, climate change and environmental organizations, technology developers, academia, maritime industry, ports, and finance to catalyze collaboration and innovation for climate action in the maritime sector. Particular emphasis is placed on north-south and south-south collaboration for promoting inclusive innovation to accelerate the transition of the marine sector towards a zero- and low-emission future and is focused on addressing the specific needs of developing countries, especially SIDS and LDCs. The event is organized in partnership with the United Nations Environment Programme (UNEP) and funded by the Government of Norway (\$644,991 over four years). The fourth Innovation Forum will take place in October 2024.

⁹⁶ IMO and the Maritime and Port Authority of Singapore (MPA) jointly launched **NextGEN Connect** ("GEN" stands for "Green and Efficient Navigation"). The aim has been to bring together industry stakeholders, academia and global research centres to offer inclusive solutions for maritime decarbonization for trials along specific shipping routes. The launch was made during the IMO-Singapore Future of Shipping Conference: Decarbonization (6 April 2022). Under NextGEN Connect, diverse stakeholders were invited to propose robust methodologies to jointly develop, on a pilot basis, route-based action plans to reduce greenhouse gas emissions between specific points along a shipping route in the Asia-Pacific region. Following the review of proposals by an expert panel, a winner was announced during the Singapore Maritime Week (24 to 28 April 2023), and work is currently underway to develop case studies for potential route-based actions between different ports. Furthermore, the NextGEN database (nextgen.imo.org/) currently lists more than 430 decarbonization projects with just under 1,000 stakeholders worldwide, including IMO Member States, shipowners, technology developers, classification societies and non-governmental organizations.

97 The third **IMO-EBRD-World Bank FIN-SMART Roundtable** was held on 23 June 2023 at the European Bank for Reconstruction and Development (EBRD) headquarters in London.

More than 50 leaders from the financial, public and private sectors participated in the Third "Financing Sustainable Maritime Transport (FIN-SMART) Roundtable" to discuss ongoing pilots, potential bankable proposals and overall raise importance of multi-development banks investing in green shipping. The Roundtable aims to support accelerating financial flows, particularly in developing countries, for the decarbonization of the maritime sector, in line with country priorities and the objectives of the *2023 IMO Strategy on Reduction of GHG Emissions from Ships*.

98 The preparatory phase of the **Blue Solutions** project, an Asia Maritime Transport Emissions project that aims to support East and Southeast Asian countries in identifying opportunities to prevent and reduce transport emissions, was submitted for approval in 2022 to the International Climate Initiative (IKI) of the Federal Ministry for the Environment, Nature Conservation and Nuclear Safety of Germany (BMU). The full-size project, once approved, will target the reduction of GHG and other pollutant emissions from ships within ports, and from hinterland transport through energy efficiency improvements, optimized processes and innovative technologies (blue solutions).

Oceans-related projects

⁹⁹ "Building Partnerships to Assist Developing Countries to Minimize the Impacts from Aquatic Biofouling" (**GEF-UNDP-IMO GloFouling Partnerships** project) is part of a wider IMO effort, in collaboration with UNDP and the Global Environment Facility (GEF), to protect marine ecosystems from the negative effects of invasive aquatic species. The seed funding is provided by **GEF (\$6.9 million**). The Project fosters an intervention in 12 beneficiary countries and 14 partnering countries in six regions at multiple levels: driving legal, policy and institutional reforms in countries to implement the IMO Biofouling Guidelines; developing capacity to enact a national policy; and bringing in active private sector participation to identify effective solutions and technologies to deal with biofouling. The project also looks at GHG emissions resulting from biofouling on ships.

100 During 2023, the project organized and delivered the first ever Arab Women in Maritime – Biofouling Management Workshop from 10 to 11 May, hosted by the Kingdom of Saudi Arabia in Jeddah. The workshop provided the opportunity for women from 18 MENA countries to enhance their knowledge on the topic of biofouling and its effects and in return to share their practical knowledge by identifying the gaps related to gender equality and finding solutions, GloFouling Partnerships also organized and delivered an international workshop on biofouling management to prevent invasive aguatic species in Marine Protected Areas (MPAs) and Particularly Sensitive Sea Areas (PSSAs) from 6 to 9 June, which was hosted by Ecuador in Galapagos Islands. The workshop provided experts from 20 countries with an opportunity to exchange views, methods and practices for prevention, risk assessment, inspection, monitoring, early detection and rapid response to the introduction of invasive species via ships' biofouling. The project developed and delivered in its seven out of twelve lead partnering countries a training course focusing on the development of Biofouling Management Plans (BFMPs) and Biofouling Management Record Books (BFRBs) - key element of IMO's Biofouling Guidelines. In 2023, the GloFouling project also finalized and published two proceedings documents: one from the second Global Project Task Force meeting that took place in April 2022, and another from the second GloFouling Partnerships Forum and Exhibition on Biofouling Prevention and Management for Maritime Industries that took place in October 2022.

101 The "Accelerating Transfer of Environmentally sound Technologies through demonstration pilots to reduce biofouling and related emissions" (**TEST Biofouling**) Project, launched in 2022, is funded by the **Norwegian Agency for Development Cooperation** (**Norad**) (\$4 million) and will assist developing countries to build their knowledge on control

and management of biofouling and showcase effective approaches to biofouling management and the mitigation of environmental risks associated with the transfer of invasive aquatic species through biofouling by means of demonstration projects at both regional and country level. In 2023, the project delivered a series of online and virtual training courses (developed by the GloFouling Partnerships project) on "Introduction to Marine Biofouling: Impacts and Management of Risks" to the project's Partnering Countries (PCs). Furthermore, a thorough country status analysis on biofouling management was conducted and the project is entering the phase of utilizing technology demonstration pilots at both regional and national levels.

As part of the Project's commitment to SDG 5, it continues to operationalize activities based on the Gender Action Plan (GAP) developed by the Project, which facilitates collaboration and knowledge sharing, and aims to address the unique challenges women face in the biofouling field. The project developed two analysis reports and e-publications on women in biofouling and women's participation in biofouling related industries. Additionally, the project supported the participation of women representing the project's lead partnering countries (LPCs) and partnering countries, namely Jordan and Nigeria at the Maritime SheEO event (21 November 2023) to emphasize the valuable contributions and the indispensable role they play in the biofouling industry, advocating for broader recognition and encouragement of diversity. The Project has created a social media campaign to showcase "He for She" and "She Champions" in the biofouling industry. The campaign promotes the achievements of individuals within an effective biofouling industry that benefits from the full range of values and perspectives that both men and women bring to the field. It further encourages stakeholders to actively embrace gender diversity in the relevant fields of the biofouling industry.

103 The Sea Based Marine Plastic Litter (SBMPL) Portfolio has been created to allow all marine plastic litter projects to collaborate on tackling the issue. The project spearheading these efforts, IMO-FAO GloLitter Partnerships Project, is funded mainly by Norway and further funding has been secured from Australia and the Kingdom of Saudi Arabia totaling \$4.5 million. GloLitter has been working with the LPCs on finalizing NAPs to ensure that the implementation of priorities identified in NAPs can continue through 2024. Nine NAPs have been published and two more are due to be completed soon. The NAP activities prioritize actions to address Sea-Based Marine Plastic Litter (SBMPL) on a national level in accordance with MARPOL Annex V, London Convention/London Protocol, and the IMO Action Plan to Address Marine Plastic Litter from ships. The finalization of the NAPs will allow countries to proceed with twinning arrangements with PCs in their regions, working together on common issues related to marine plastic litter with the support from the GloLitter project. Some regions have established twinning activity proposals, and one example is Costa Rica as LPC requesting along with the PCs of the region a Regional Action Plan. A consultant has been identified to further this regional activity.

104 The second project under the **SBMPL Portfolio is the Regional Litter Project**, **RegLitter**, funded by the Republic of Korea with an available budget of \$5.5 million. RegLitter will build on the results of the GloLitter project with a specific focus on countries in Asia. Countries who are Partner Countries under the GloLitter project will have support in developing their own NAPs and LPCs under the GloLitter project will have further support in actioning activities included in the NAP developed under GloLitter. RegLitter is essentially phase 2 of GloLitter for the countries participating from the Asia region.

105 The third project under the **SBMPL Portfolio is the PRO-SEAS project**, which will take four countries from the GloLitter project and essentially be the phase 2 for those countries. These countries all have NAPs and the project will focus on specific activities identified in the NAPs for the project to implement. This project is in its preparatory phase and as such the project document is still being developed. If approved, GEF will formalize the project and provide \$7m as support.

106 The **SENSREC Project** assists developing countries in the implementation of the Hong Kong Convention for the Safe and Environmentally Sound Recycling of Ships. Launched in Bangladesh in 2015, the Project is funded by the Norwegian Ministry of Foreign Affairs. In 2023, as a result of the work developed by the SENSREC project, Bangladesh acceded to the Hong Kong Convention and helped to fulfil the requirements for its entry into force, which has been established for June 2025. During 2023, SENSREC finalized activities remaining from the second phase, such as an assessment of the challenges and barriers to the entry of women into the ship recycling workforce in Bangladesh. At the end of 2023, SENSREC held an inception workshop to launch its third phase in Bangladesh, which will focus on supporting the national industry and will assist the establishment of infrastructure for downstream hazardous waste management in Chattogram.

107 The Global Partnership for Mitigation of Underwater Noise from Shipping (GloNoise Partnership) project has entered the implementation phase with the signature of the final version of the project document in December 2023 by GEF-UNDP and IMO. The overall objective of the GloNoise Partnership project is to establish a truly global stakeholders' partnership, with a strong focus on developing countries, in order to deal with the major environmental issue of underwater noise from shipping. The specific objective of the project is to assist developing countries and regions to raise awareness, to build capacity and to collect information to assist the policy dialogue on anthropogenic underwater noise mitigation from shipping. The project is based on IMO's Guidelines for the reduction of underwater noise from commercial shipping to address adverse impacts on marine life, and its future revisions, and relevant policy discussions at multiple levels. The project has six lead pilot countries: Argentina, Chile, Costa Rica, India, South Africa and Trinidad and Tobago, and three twinning countries: Georgia, Madagascar and Malaysia, in addition to the strategic partners.

SMART-C Programme

108 In 2023, IMO and the Republic of Korea signed a suite of agreements to formally establish and boost the **IMO-Republic of Korea Sustainable Maritime Transport Cooperation (SMART-C) Programme**. The goal of the KRW 25.5 billion (approximately \$20 million) SMART-C Programme is to promote sustainable maritime transport systems and a sustainable marine environment by building knowledge and developing technical capacity in developing countries via long-term thematic projects. The SMART-C Programme has so far initiated five projects, namely SMART-C Women, SMART-C Traffic, SMART-C GHG, SMART-C Leaders and SMART-C RegLitter.

SMART-C Women – Strengthening Women's Competencies in the Sustainable Maritime Transport Sector through upgrading skills related to Maritime Digitalization and Marine Environmental Protection (2023-2026). The goal of the project is to contribute to the achievement of gender equality through the increase of employment opportunities for women in the maritime sector in developing countries, in the Asia and Pacific regions, and the provision of training to help them advance their careers in related industries. Specifically, the project will provide female officials in beneficiary countries with online and in-person training that will strengthen their competencies in environmental and digital technologies to prepare them for the emerging opportunities within the maritime sector, while also supporting them to acquire new educational qualifications through fellowships at the World Maritime University.

SMART-C Traffic – Development of a SMART-Maritime Traffic Management System and Improvement of Related Operational Capability in a Pilot Developing Country (the Philippines) (2023-2026). The goal of the project is to develop, operate and pilot trial a web-based e-Navigation service that can efficiently analyze and manage maritime safety information in an Internet-based environment. **SMART-C GHG** – Capacity building in two Asian pilot countries for developing National Action Plans and implementation of the IMO GHG Strategy with the help of GHG Emission Data from Maritime Sector (2023-2027). This project aims at the implementation of the maritime GHG reduction regulations by building relevant capacity for baseline emission data collection, management, and analysis, in accordance with the 2023 IMO GHG Strategy.

SMART-C Leaders – Capacity-building on Implementation of IMO Conventions and Professional Training for International Maritime Leaders (2023-2027). The goal of the project is to improve the Pacific SIDS' capacity in ship inspection/port State control (PSC)/flag State inspection (FSI) and help the country's implementation of the corrective action plan (CAP) established after its audit under the IMO Member State Audit Scheme.

Maritime security projects

113 The EU-funded project on **Port Security and Safety of Navigation in Eastern and Southern Africa and the Indian Ocean** continues to work closely with National Focal Points and IMO Representatives to implement agreed activities. Participating States include Angola, Comoros, Kenya, Madagascar, Mauritius, Mozambique, Namibia, Seychelles and Tanzania. Having begun with activities related to the review of the status of implementation of IMO instruments, followed by the identification of obstacles hampering the transposition of the main IMO instruments into national legislation, assistance was provided regarding the drafting of legislation related to the maritime security measures.

114 During 2023, the focus of implementation widened to include the delivery of training regarding control and compliance with chapter XI/2 of SOLAS, as well as support to the conduct of ISPS Code PFSAs and (support to) the formulation of subsequent PFSPs. Collaboration continued with participating Member States regarding ISPS Code implementation and assistance has been provided to conduct on-site surveys of designated ports and port facilities as nominated by each Member State. Workplans have also been revisited, with the agreement of a no-cost extension of up to 24 months, following the Project's second Steering Committee meeting held in Cape Town in May 2023.

115 The **Regional Programme for Maritime Security in the Red Sea Area**, which is funded by the European Union (\in 5.25 million total funding for IMO), was launched in February 2021 in Djibouti. Under this programme, IMO is engaged in coordinated actions with the International Criminal Police Organization (INTERPOL), the United Nations Office on Drugs and Crime (UNODC), and the Intergovernmental Authority on Development (IGAD), in support of participating countries, namely Djibouti, Ethiopia, Somalia, Sudan and Yemen, to develop capacities and promote adequate security and safety standards for maritime, port and land-based law-enforcement authorities, in line with the objectives of the 2050 Africa's Integrated Maritime Strategy.

116 During 2023, IMO's work focused on enhanced ISPS Code implementation, namely supporting participating countries in the establishment of a Whole of Government approach towards maritime security, which promotes cooperation between government agencies with an interest in maritime security. Activities promoted the establishment of national maritime security committees the development of a national maritime security risk register and of a national maritime security strategy. Expert support was also provided to the conduct of ISPS Code PFSAs.

117 The **Implementation of the Djibouti Code of Conduct** (DCoC) continued to support Member States in the Western Indian Ocean and the Gulf of Aden in building capacity to counter piracy and other threats to maritime security. The focus during 2023 was on implementing priorities agreed upon at the two high-level meetings in Dubai (May 2022) and Jeddah (November 2022), including the implementation of the strategy and roadmap for the development of the DCoC information-sharing network, improved coordination of capacity-building efforts, and taking action to address new and emerging threats to maritime coordination. As a priority, participating States have been working to build national capabilities through the implementation of the "IMO model on the Whole of Government Approach."

118 Signatory States maintained a lively calendar of activities, including meetings of the Steering Committee, Working Group One spearheading the development of the DCoC information-sharing network, including for the establishment of multi-agency National Maritime Information Sharing Centres in all participating States. Furthermore, Working Group Two on capacity-building coordination was expanded to cover the various thematic areas envisioned in the Jeddah Amendment.

119 The Signatory States maintained good collaboration with international partners through the "Friends of DCoC" forum to ensure that technical assistance and support are based on the identified gaps and priorities highlighted in the DCoC capacity-building coordination matrix hosted on the Members-only portal of the DCoC Website. In October 2023, the high-level meeting held in Cape Town agreed on the need to develop a DCoC regional maritime security strategy and agreed on the need to encourage coordination of operations at sea to effectively deal with the increasing threats to maritime security.

120 Since November 2023, the DCoC has been concerned with the escalating security situation in the Red Sea area and aiming to find sustainable solutions.

121 The **West and Central Africa Maritime Security Programme** aims to deliver capacity-building activities focusing on providing direct assistance to Member States in the region with a view to developing and enhancing their ability to address issues and challenges in their maritime domains. The programme is funded by contributions to the IMO West and Central Africa Maritime Security Trust Fund and bilateral contributions.

122 Thanks to a contribution from the Government of the United Kingdom, IMO continues to provide an expert to support Member States in the Gulf of Guinea through the continued implementation of the Yaoundé Code of Conduct (YCoC), signed by the 25 Member States of the Economic Community of West African States (ECOWAS), the Economic Community of Central African States (ECCAS) and the Gulf of Guinea Commission (GGC) on 25 June 2013. The key focus is building sustainable regional maritime security cooperation through improved security governance – which will enable enhanced response against maritime criminality, and effective and efficient legal adjudication of piracy and armed robbery incidents against ships. This effort utilizes a "Whole of Government" approach, ongoing support for the YCoC regional architecture, and effective coordination of international partner efforts.

Additionally, thanks to a contribution from the Republic of Korea, IMO has enhanced communication at the Multinational Maritime Coordination Centre (MMCC) ECOWAS Zone F and promoted maritime safety and security within Zone F and the Gulf of Guinea. A follow-on project in ECCAS Zone D using this Republic of Korea funding is planned for the first quarter of 2024.

124 In December 2023, IMO signed a €2 million agreement with Germany to fund the "Boosting African Implementation of the YCoC" (BAY) project (2024-2025). In addition to support targeted to ECCAS, ECOWAS, GGC, as well as the regional and national bodies of the YCoC architecture, the project will provide direct support to the Inter-regional Coordination Centre (ICC), based in Yaoundé, Cameroon, which plays a strategic role in fostering cooperation in the region.

125 IMO acknowledges with thanks the financial contributions from Germany, Republic of Korea and United Kingdom to the IMO WCA Maritime Security Trust Fund.
