The Mission of the Russian Federation to the International Maritime Organization (IMO) presents its compliments to the Secretary-General of the IMO and with reference to the outcomes of the 35th Council's extraordinary session, as represented in C/ES/35/WP.1/Rev.1, in particular its paragraph 3.2, on the "establishment, as a provisional and urgent measure, of a blue safe maritime corridor to allow safe evacuation of seafarers and ships" in the Black Sea and the Sea of Azov would like to inform of the following steps undertaken by the Russian side.

With the aim of ensuring safe passage from the ports of the Ukraine (ports of Chernomorsk, Kherson, Mykolaiv, Ochakov, Odesa and Yuzhne) of merchant vessels there will be established a humanitarian maritime corridor starting from 27 March 2022 (please, find sketch-map enclosed). This corridor represents an 80-mile long and 3-mile wide marine traffic lane from the assembly area (RC-1) to the exit area (RR-2). General course is 200°. The corridor will operate daily from 8 a.m. to 7 p.m. (UTC+3).
