The validity of the endorsement is further extended to 31 December 2020, upon remote request by the Company, subject to the following conditions and limitations:

- 1 Without prejudice to the validity of the certificate of competency issued by the foreign state, the extension cannot continue beyond 31 December 2020;
- 2 The extension is granted, according to the new form attached to this letter, to foreign seafarers who are already on board or about to go on board and who hold a certificate of competency that has been renewed or extended by the state that originally issued it.

In view of the continuing health emergency, further to what was established in the aforementioned circular, it is hereby communicated that certificates of competency held by seafarers who are already on board or are about to go on board are automatically extended to 31/12/2020 with no need for the holder to submit an application. The following limitations apply:

- a) The validity of the certificate cannot be extended beyond 31/12/2020;
- b) The extension is granted to personnel already on board who hold certificates of competency that have expired or are about to expire and to personnel about to go on board.
